PART A

Changes effected by Order of the Secretary of State under the Local Government and Public Involvement in Health Act 2007

There are 7 structural change Orders establishing unitary local authorities.

THE BEDFORDSHIRE (STRUCTURAL CHANGES) ORDER 2008 – S.I. 2008 NO. 907

This Order was made on 27 March 2008. It abolishes the districts of Mid Bedfordshire and South Bedfordshire and the administrative county of Bedfordshire and creates two new unitary authorities of Bedford Borough and Central Bedfordshire from 1 April 2009. The Order cancelled elections in 2008 for Bedford Borough and South Bedfordshire and provides for elections in 2009 for Bedford and Central Bedfordshire with next elections in 2011 and every four years thereafter.

THE CHESHIRE (STRUCTURAL CHANGES) ORDER 2008 – S.I. 2008 NO. 634

This Order was made on 4 March 2008. It abolishes the boroughs of Congleton, Crewe and Nantwich, Ellesmere Port and Neston, Macclesfield and Vale Royal, the city of Chester and the administrative county of Cheshire and creates two new unitary authorities of Cheshire East, and Cheshire West and Chester from 1 April 2009. The Order cancelled the district council elections in 2008 but provided for elections to the two new councils in May 2008 with next elections in 2011 and every four years thereafter. It also cancels any parish elections due in 2010 and provides for the next parish elections to be in 2011.

THE CORNWALL (STRUCTURAL CHANGE) ORDER 2008 – S.I. 2008 NO. 491

This Order was made on 25 February 2008. It abolishes the borough of Restormel and the districts of Caradon, Carrick, Kerrier, North Cornwall and Penwith and establishes a single new unitary authority of Cornwall from 1 April 2009. The Order cancelled the district and parish council elections in 2008, and provides for elections for the new unitary council and some parishes in 2009. It also provides for the cancellation of parish elections due in 2011; all parishes will in future hold elections in 2013 and every four years thereafter.

THE COUNTY DURHAM (STRUCTURAL CHANGE) ORDER 2008 – S.I. 2008 NO. 493

This Order was made on 25 February 2008. It abolishes the borough of Sedgefield, the city of Durham and the districts of Chester-Le-Street, Derwentside, Easington, Teesdale and Wear Valley and establishes a single new unitary authority of County Durham from 1 April 2009. The Order directed the County Durham Council to hold whole council elections in 2008, 2013 and every four years thereafter. It also cancels

parish council elections in 2011, and provides for those parish elections to take place in 2013 and every four years thereafter.

THE NORTHUMBERLAND (STRUCTURAL CHANGE) ORDER 2008 – S.I. 2008 NO. 494

This Order was made on 25 February 2008. It abolishes the boroughs of Berwick-upon-Tweed, Blyth Valley and Castle Morpeth and the districts of Alnwick, Tynedale and Wansbeck and establishes a single new unitary authority for Northumberland from 1 April 2009. The Order directed the Northumberland Council to hold whole council elections in 2008, 2013 and every four years thereafter. It also cancels the parish council elections in 2011, and provides for those parish elections to take place in 2013 and every four years thereafter.

THE SHROPSHIRE (STRUCTURAL CHANGE) ORDER 2008 – S.I. 2008 NO. 492

This Order was made on 25 February 2008. It abolishes the boroughs of Oswestry, and Shrewsbury and Atcham and the districts of Bridgnorth, North Shropshire and South Shropshire and establishes a single new unitary authority of Shropshire from 1 April 2009. The Order cancelled the district and parish council elections to be held in 2008 and provides for elections for the new unitary council and some parishes to be held in 2009. It also provides for the cancellation of parish elections due in 2011; all parishes will in future hold elections in 2013 and every four years thereafter.

THE WILTSHIRE (STRUCTURAL CHANGE) ORDER 2008 – S.I. 2008 NO. 490

This Order was made on 25 February 2008. It abolishes the districts of Kennet, North Wiltshire, Salisbury and West Wiltshire and establishes a single new unitary authority of Wiltshire from 1 April 2009. The Order provides for the cancellation of parish elections due in 2011; all parishes will in future hold elections in 2013 and every four years thereafter.

THE BERWICK-UPON-TWEED (PARISHES) ORDER 2008 – S.I. 2008 NO. 290

*This Order created a new parish of Berwick-upon-Tweed and made alterations to the parishes of Akeld, Chatton, Earle, Horncliffe, Ilderton, Ingram, Lilburn, Norham, Ord, Roddam and Wooler and the un-parished area. The Order directed the Berwick-upon-Tweed Borough Council to establish a parish council for the new parish. The Order was made on 7 February 2008 and came into effect on 1 April 2008.

THE CHELTENHAM (PARISHES) (AMENDMENT) ORDER 2007 – S.I. 2007 NO. 3421

This Order amended and substituted the Maps of the Cheltenham (Parishes) Order 2003. The substitute maps correct errors in the existing maps relating to the boundary between the parish of Swindon and the unparished area of Cheltenham. This Order was made on 28 November 2007 and came into effect on 28 November 2007.

THE COTSWOLD (PARISHES) ORDER 2008 – S.I. 2008 NO. 304

This Order transferred areas between the parishes of Ampney St Mary, Ampney St Peter and Poulton. The Order was made on 7 February 2008 and came into effect on 1 April 2008.

THE EAST DEVON (PARISHES) ORDER 2008 – S.I. 2007 NO. 3422

The Order transferred areas between the parishes of Feniton, Gittisham, Honiton, Ottery St Mary, Talaton. The Order was made on 28 November 2007 and came into effect on 1 April 2008.

THE HARBOROUGH (PARISHES) ORDER 2007 – S.I. 2007 NO. 2705

This Order transferred areas between the parishes of Drayton, Great Bowden and Medbourne and the un-parished area of the district of Harborough. The Order was made on 11 September 2007 and came into effect on 1 April 2008.

THE HIGH PEAK (PARISHES) ORDER 2008 – S.I. 2008 NO. 303

This Order transferred an area between the parishes of Chapel-en-le-Frith and Chinley, Buxworth and Brownside. The Order was made on 7 February 2008 and came into effect on 1 April 2008.

THE KETTERING (PARISH) ORDER 2008 – S.I. 2008 NO. 602

This Order transferred an area between the parish of Weekley and the un-parished area of the borough of Kettering. The Order was made on 4 March 2008 and came into effect on 1 April 2008.

THE MAIDSTONE (PARISHES) ORDER 2007 – S.I. 2007 NO. 3576

This Order transferred areas between the parishes of Boughton Monchelsea, Chart Sutton, Collier Street, Coxheath, Loose, Tovil and Yalding. The Order was made on 14 December 2007 and came into effect 1 April 2008.

THE NEWARK AND SHERWOOD (PARISH) ORDER 2008 – S.I. 2008 NO. 179

*This Order created a new parish of Fernwood. The Order directed the Newark and Sherwood District Council to establish a parish council for the new parish. The Order was made on 25 January 2008 and came into effect on 1 April 2008.

THE NORTH NORFOLK (PARISHES) ORDER 2008 – S.I. 2008 NO. 180

*This Order created a new parish of Walcott and made alterations to the parishes of Beeston Regis, Gresham, Matlaske and Runton. The Order directed the North Norfolk District Council to establish a parish council for the new parish. The Order was made on 25 January 2008 and came into effect on 1 April 2008.

THE OXFORD (PARISHES) ORDER 2008 – S.I. 2008 NO. 372

This Order transferred areas between the parishes of Littlemore and Risinghurst and Sandhills and the un-parished area of the city of Oxford. The Order was made on 12 February 2008 and came into effect on 1 April 2008.

THE PENDLE (PARISHES) ORDER 2008 – S.I. 2008 NO. 549

*This Order created two new parishes of Colne and Nelson and made alterations to parishes of Brierfield, Foulridge and Kelbrook and Sough. The Order directed the Pendle Borough Council to establish parish councils for each of the new parishes. The Order was made on 28 February 2008 and came into effect on 1 April 2008.

THE ST HELENS (PARISH) ORDER 2008 – S.I. 2008 NO. 603

This Order transferred an area between the parish of Seneley Green and the un-parished area of the borough of St Helens. The Order was made on 4 March 2008 and came into effect on 1 April 2008.

THE SEVENOAKS (PARISHES) ORDER 2008 – S.I. 2008 NO. 422

*This Order created a new parish called Hextable within the district of Sevenoaks. The Order directed the Sevenoaks District Council to establish a parish council for the new parish. The Order was made on 18 February 2008 and came into effect on 1 April 2008.

THE STROUD (PARISHES) ORDER 2007 – S.I. 2007 NO. 2955

This Order transferred areas between the parishes of Minchinhampton, Nailsworth and Woodchester. The Order was made on 5 October 2007 and came into effect on 1 April 2008

THE TEWKESBURY (PARISHES) ORDER 2007 – S.I. 2007 NO. 3577

*This Order abolished the parishes of Ashchurch and Walton Cardiff; created three new parishes of Ashchurch Rural, Northway and Wheatpieces and made alterations to the parishes of Alderton, Ashchurch, Badgeworth, Bishop's Cleeve, Brockworth, Churchdown, Deerhurst, Elmstone Hardwicke, Hucclecote, Innsworth, Shurdington, Southam, Stoke Orchard, Tewkesbury, Toddington and Woodmancote. The Order directed the Tewkesbury Borough Council to establish parish councils for each of the new parishes. The Order was made on 14 December 2007 and came into effect on 1 April 2008.

THE DERWENTSIDE (PARISH) ORDER 2007 – S.I. 2007 NO. 1185

*This Order created a new parish called Stanley. The Order directed the Derwentside District Council to establish a parish council for the new parish. The Order was made on 11 April 2007 and came into effect on 1 April 2008.

THE ELLESMERE PORT AND NESTON (PARISH) ORDER 2007 – S.I. 2007 NO. 3578

*This Order created a new parish called Neston. The Order directed the Ellesmere Port and Neston Borough Council to establish a parish council for the new parish. The Order was made on 19 December 2007 and came into effect on 1 April 2008.

THE ELLESMERE PORT AND NESTON (PARISH) (AMENDMENT) ORDER 2008 – S.I. 2008 NO. 980

This Order amended the Ellesmere Port and Neston (Parish) Order 2007 by altering the coming into force date for the new parish of Neston and the Order Date from 1 April 2008 to 1 April 2009. The Order was made on 28 March 2008 and shall come into effect on 1 April 2009.

THE HALTON (PARISHES) ORDER 2007 – S.I. 2007 NO. 3003

*This Order created two new parishes of Halebank and Sandymoor. The Order directed the Halton Borough Council to establish parish councils for the new parishes. The Order was made on 18 October 2007 and came into effect on 1 April 2008.

THE HERTSMERE (PARISH) ORDER 2008 – S.I. 2008 NO. 43

*This Order created a new parish called South Mimms. The Order directed the Hertsmere Borough Council to establish a parish council for the new parish. The Order was made on 10 January 2008 and came into effect on 1 April 2008.

THE ISLE OF WIGHT (PARISHES) ORDER 2008 – S.I. 2008 NO. 376

*This Order created four new parishes of Newport, Northwood, Ryde and Whippingham. The Order directed the Isle of Wight Council to establish parish councils for each of the new parishes. The Order was made on 12 February 2008 and came into effect on 1 April 2008.

THE LEEDS (PARISH) ORDER 2008 – S.I. 2008 NO. 421

*This Order created a new parish of Alwoodley. The Order directed the Leeds City Council to establish a parish council for the new parish. The Order was made on 18 February 2008 and came into effect on 1 April 2008.

THE NEWPORT, NORTHWOOD, RYDE AND WHIPPINGHAM PARISH COUNCIL ORDER 2008 (ISLE OF WIGHT COUNCIL)

Established parish councils for the parishes of Newport, Northwood, Ryde and Whippingham and made electoral arrangements. This Order was made on 26 March 2008 and came into effect on the day after it was made.

SANDYMOOR PARISH COUNCIL ORDER 2008 (HALTON BOROUGH COUNCIL)

Established a parish council for the parish of Sandymoor and made electoral arrangements. This Order was made on 12 March 2008 and came into effect on the day after it was made.

WALCOTT PARISH COUNCIL ORDER 2008 (NORTH NORFOLK DISTRICT COUNCIL)

Established a parish council for the parish of Walcott and made electoral arrangements. This Order was made on 29 February 2008 and came into effect on the day it was made.

PARISH OF COMBE FIELDS (COUNCILLORS) ORDER 2007 (RUGBY BOROUGH COUNCIL)

Increases the number of councillors from five to six. This Order was made on 19 November 2007.

THE EASINGWOLD TOWN COUNCIL (REDUCTION OF COUNCILLORS) ORDER 2007 (HAMBLETON DISTRICT COUNCIL)

Reduces the number of councillors from 11 to 8. This Order was made on 11 October 2007 and came into effect on 22 October 2007.

THE PARISH OF FOREST ROW (ELECTORAL ARRANGEMENTS AND ELECTORAL CHANGES) ORDER 2007 (WEALDEN DISTRICT COUNCIL)

Set the number of wards and councillors for the parish of Forest Row in the district of Wealden. This Order was made on 25 April 2007 and came into effect on 3 May 2007.

THE ISLE OF WIGHT (PARISH ELECTORAL ARRANGEMENTS) ORDER 2008

Sets the number of wards and councillors for the parishes of Newport, Northwood, Ryde and Whippingham. This Order was made on 26 March 2008 and came into effect on the day after it was made.

¹THE SIMONSTONE (ENLARGEMENT OF PARISH COUNCIL) ORDER 2006 (RIBBLE VALLEY BOROUGH COUNCIL)

Increased the number of councillors from seven to eight. This Order was made on 10 October 2006.

²TELSCOMBE TOWN COUNCIL (COUNCILLORS) ORDER 2006 (LEWES DISTRICT COUNCIL)

Reduced the number of councillors from 19 to 13. This Order was made on 8 June 2006.
