ALTERATIONS TO BOUNDARIES OF LOCAL AUTHORITIES - PART IV  
THE FOLLOWING BOUNDARY CHANGES CAME INTO EFFECT ON 1 APRIL 1980

## CORNWALL

In the district of Penwith, the order constitutes a new parish called Penzance in the former borough of Penzance by the Penzance (PARISHES) order (S.I. 1980 No 32).

## DERBYSHIRE

6 new parishes have been created in the former urban district of Matlock in the district of West Derbyshire by the West Derbyshire (PARISHES) order (S. I. 1980 No 363) viz the Parishes of Bonsall; Darley Dale; Matlock Bath; Northwood and Tinkersley; South Darley; Tansley.

## LANCASHIRE

The Lancaster City Council (PARISHES) order (S.I 1980 No 415) effects the transfer of one whole parish and parts of other parishes, in the City of Lancaster, to other parishes. There are also some adjustments between parishes and in a part of the city which is not comprised in any parish.

## NOTTINGHAMSHIRE

The Gedling Borough Council (PARISHES) order (S.I 1980 No 271) constitutes a new parish in the Borough of Gedling, viz the Parish of Colwick. It also effects the inclusion of two areas of the former urban districts of Arnold and Carlton in parishes.

1 new parish has been created in the former borough of Newark in the District of Newark by the Newark (PARISHES) Order (S.I. 1980 No 302) viz the Parish of Newark.

## STAFFORDSHIRE

1 new parish (comprising mainly the former borough of Lichfield) has been created in the District of Lichfield by the Lichfield (Parishes) order (S.I 1980 No 387) viz the Parish of Lichfield. The order also effects the inclusion of the remainder of the area of the former city in parishes and also effects other transfers as between parishes.
