PART B

CHANGES EFFECTED BY ORDER OF THE SECRETARY OF STATE FOR THE ENVIRONMENT UNDER PART IV OF THE LOCAL GOVERNMENT ACT 1972

The following Orders altering the boundaries of Counties or Districts or Parishes, or creating new Parishes or abolishing Parishes, came into effect on or before 1 April 1989.

BEDFORDSHIRE AND HERTFORDSHIRE

The Bedfordshire and Hertfordshire (County Boundaries) Order 1989 (S.I. 1989 No.284)

This Order transfers a small area from the county of Hertfordshire and district of North Hertfordshire to the county of Bedfordshire and borough of Luton.

The North Bedfordshire (Parishes) Order 1989 (S.I. 1989 No.402)

This Order transfers areas between parishes, and from a parish into an unparished area, in the district of North Bedfordshire.

BERKSHIRE

The Windsor and Maidenhead (Parishes) Order 1988 (S.I. 1988 No.2207)

This Order creates a new parish and parish council of Cox Green in the borough of Windsor and Maidenhead, and transfers areas between the parishes of Bray and White Waltham and from the unparished area of the borough to White Waltham.

CAMBRIDGESHIRE

The Cambridgeshire, Essex, Hertfordshire and Lincolnshire (County Boundaries) Order 1989 (S.I. 1989 No.133)

This Order transfers areas between the counties of Cambridgeshire, Essex, Hertfordshire and Lincolnshire, affecting the districts of South Kesteven, South Holland, Peterborough, Fenland, South Cambridgeshire, North Herts, Uttlesford.

CLEVELAND AND DURHAM

The Cleveland and Durham (County Boundaries) Order 1988 (S.I. 1988 No.2180)

This Order transfers areas between the county of Cleveland and borough of Stockton-on-Tees and the county of Durham and the district of Sedgfield.

CUMBRIA AND LANCASHIRE

The Cumbria and Lancashire (County Boundaries) Order 1988 (S.I. 1988 No.2179)

This Order transfers areas between the county of Cumbria and the district of South Lakeland and the county of Lancashire and City of Lancaster.

ESSEX

The St Edmundsbury (Parish of Haverhill) Order 1989 (S.I. 1989 No.95)

This Order creates a new parish and parish council of Haverhill in the borough of St Edmundsbury.

The St Edmundsbury (Parishes) Order 1988 (Variation of Supplementary Provision) Order 1989 (S.I. 1989 No.70)

This Order varies the St Edmundsbury (Parishes) Order 1988 (S.I. 1988/325) by substituting a new article 8(3) (representations of Horringer and Horringer Court borough wards).

The Uttlesford (Parishes) Order 1988 (S.I. 1988 No.1528)

This Order affects parishes in the district of Uttlesford by transferring part of the parish of Hatfield Broad Oak to the parish of Takeley.

ISLE OF WIGHT

The Medina (Parish of Seaview) Order 1988 (SI 1988 No 1795)

This Order creates in the borough of Medina a new parish and parish council of Seaview.

KENT

The Dartford (Parishes) Order 1989 (S.I. 1989 No.108)

This Order affects parishes in the borough of Dartford. It -

(a) creates a new parish and parish council of Bean from part of the parish of Stone; and

(b) transfers an area from the parish of Stone to the parish of Darenth.

The Tonbridge and Malling (Parishes) Order 1989 (S.I. 1989 No.269)

This Order transfers a part of the parish of East Malling and Larkfield in the borough of Tonbridge and Malling to the parish of Leybourne.

LINCOLNSHIRE AND NOTTINGHAMSHIRE

The Lincolnshire and Nottinghamshire (County Boundaries) Order 1989 (S.I. 1989 No.210)

This Order transfers areas between the county of Lincolnshire and districts of North Kesteven and West Lindsey and the county of Nottinghamshire and district of Newark and Sherwood.

NORTHANTS

The Kettering (Parishes) Order 1988 (S.I. 1988 No.2262)

This Order transfers areas between parishes, and between a parish and the unparished area, within the Borough of Kettering.

The Melton (Parishes) Order 1988 (S.I. 1988 No.2100)

This Order affects parishes in the borough of Melton by transferring an area from the parish of Asfordby to the parish of Ab Kettleby.

SOMERSET

The Sedgemoor (Parishes) Order 1988 (S.I. 1988 No.1572)

This Order transfers areas between the parishes of Fiddington, Nether Stowey, and Spaxton in the district of Sedgemoor.
