CHANGES EFFECTED BY ORDER OF THE SECRETARY OF STATE FOR THE ENVIRONMENT UNDER PART IV OF THE LOCAL GOVERNMENT ACT 1972

The following Orders altering the boundaries of Counties or Districts or Parishes or creating new Parishes or abolishing Parishes, came into effect on or before 1 April 1990.

✓ AVON, SOMERSET and WILTSHIRE

The Avon, Somerset and Wiltshire (County Boundaries) Order 1990 (SI 1990 No 159)

This Order transfers areas between the counties of Avon, Somerset and Wiltshire.

✓ BEDFORDSHIRE

The Mid Bedfordshire (Parishes) Order 1989 (SI 1989 No 2040)

This Order creates a new parish and parish council of Brogborough in the district of Mid Bedfordshire.

✓ BERKSHIRE, DORSET AND WILTSHIRE

The Berkshire, Dorset and Wiltshire (County Boundaries) Order 1989 (SI 1989 (No 1213)

This Order transfers areas between the counties of Berkshire, Dorset and Wiltshire.

✓ BUCKINGHAMSHIRE

The Buckinghamshire (District Boundaries) Order 1990 (SI 1990 No 185)

This order transfers areas in the county of Buckinghamshire between the district of Chiltern and the district of South Bucks.

✓ CAMBRIDGESHIRE, NORFOLK AND SUFFOLK

The Cambridgeshire, Norfolk and Suffolk (County Boundaries) Order 1990. (SI 1990 No.228

This Order transfers areas between the counties of Cambridgeshire, Norfolk and Suffolk.

✓ CHESHIRE

The Crewe and Nantwich (Parishes) Order 1990. (SI 1990 No 576)

This Order affects parishes and the unparished area in the borough of Crewe and Nantwich.

It -

- (a) transfers areas between parishes;
- (b) transfers areas between parishes and the unparished area;
- (c) abolishes the parish of Woodcott and the Wrenbury and District Common Parish Council; and
- (d) establishes a parish council for the parish of Wrenbury cum Frith.

✓ CUMBERIA, NORTHUMBERLAND and NORTH YORKSHIRE

The Cumbria, Northumberland and North Yorkshire (County Boundaries) Order 1989 (SI 1989 No 2097)

This Order transfers areas between the counties of Cumbria, Northumberland and North Yorkshire.

✓ DEVON

The East Devon (Parishes) Order 1989 (SI 1989 No 2430)

This Order affects parishes in the district of East Devon.

It -

- (a) creates a new parish and parish council of All Saints from part of the parish of Chardstock; and
- (b) transfers areas between parishes.

✓ EAST SUSSEX

The Wealden (Parishes) Order 1990 (SI 1990 No 780)

This Order affects parishes in the district of Wealden.

It -

- (a) creates 6 new parishes from areas of existing parishes;
- (b) transfers areas between parishes.

It establishes parish councils for the new parishes.

✓ ESSEX

The Essex (District Boundaries) Order 1989 (SI 1989 No 1546)

This Order transfers an area in the county of Essex from the district of Epping Forest to the district of Harlow.

✓ ESSEX and SUFFOLK

The Essex and Suffolk (County Boundaries) Order 1989 (SI 1989 No 2352)

This Order transfers areas between the counties of Essex and Suffolk.

✓ GLOUCESTERSHIRE AND WILTSHIRE

The Gloucestershire and Wiltshire (County Boundaries) Order 1990 (SI 1990 No 170)

This Order transfers areas from the county of Wiltshire and the district of North Wiltshire to the county of Gloucestershire and the district of Cotswold.

The Stroud (Parishes) Order 1990 (SI 1990 No 260)

This Order affects parishes and the unparished area in the district of Stroud.

It -

- (a) creates 3 new parishes from areas of parishes and the unparished area, and parish councils for those parishes;
- (b) transfers areas between parishes;
- (c) transfers areas from the unparished area to parishes; and
- (d) abolishes the parish and parish council of Rodborough.

**HAMPSHIRE**

The Hampshire (District Boundaries) Order 1990 (SI 1990 No 274)

This Order transfers areas in the county of Hampshire from the district of Hart to the borough of Rushmoor and an area from the borough of Rushmoor to the district of Hart.

**HEREFORD AND WORCESTER**

The Wychavon (Parishes) Order 1989 (SI 1989 No 1721)

This Order transfers a part of the parish of Salwarpe in the district of Wychavon to the parish of Droitwich.

**HERTFORDSHIRE**

The East Hertfordshire (Parishes) Order 1990 (SI 1990 No 171)

This Order affects parishes in the district of East Hertfordshire.

It -

- (a) creates a new parish and parish council of Hertford Heath;
- (b) abolishes the parish and parish council of Little Amwell; and
- (c) transfers areas between parishes.

**KENT**

The Shepway (Parishes) Order 1990 (SI 1990 No 329)

This Order transfers areas in the district of Shepway in the County of Kent between parishes (or in some cases from or to unparished areas), and in some cases between wards of the district, and county electoral areas.

**LINCOLNSHIRE**

The East Lindsey (Parishes) Order 1989 (SI 1989 No 2073)

This Order transfers parts of the parish of Legbourne in the District of East Lindsey to the parish of Little Cawthorpe.

**NOTTINGHAMSHIRE**

The Gedling (Parishes) Order 1990 (SI 1990 No 108)

This Order transfers two areas from the unparished area of the borough of Gedling to the parish of Colwick.

The Woking (Parish of Byfleet) Order 1989 (SI 1989 No 2116)				
This Order creates in the borough of Woking a new parish and parish council of Byfleet, and makes transitional provision for parish electoral arrangements.
