The East Lindsey (Parish Electoral Arrangements) Order 2006

Made - - - - *23rd November 2006*

Coming into force in accordance with article 1(2)

East Lindsey District Council, under section 9(a) of the Local Government and Rating Act 1997 (“the 1997 Act”), have made to the Electoral Commission(b) proposals dated December 2005 for electoral arrangements in the parish of Frithville and Westville(c) in the district of East Lindsey.

The Electoral Commission have decided to give effect to those proposals.

Accordingly, the Electoral Commission, in exercise of the powers conferred by sections 14(d) and 23(e) of the 1997 Act, make the following Order:

Citation and commencement

1.—(1) This Order may be cited as the East Lindsey (Parish Electoral Arrangements) Order 2006.

(2) This Order comes into force—

- (a) for the purpose of proceedings preliminary or relating to the election of parish councillors for the parish of Frithville and Westville, to be held on the ordinary day of election of councillors(f) in 2007, on the day after that on which it is made;
- (b) for all other purposes, on the ordinary day of election of councillors in 2007.

 - (b) The Electoral Commission was established by the Political Parties, Elections and Referendums Act 2000 (c.41). The functions of the Secretary of State, under sections 13, 14 and 17(4) of the 1997 Act (c.29), to the extent that they relate to electoral arrangements within the meaning of that Act, were transferred with modifications to the Electoral Commission on 1st April 2002 (S.I. 2001/3962).
 - (c) The parishes of Frithville and Westville were amalgamated to create the parish of Frithville and Westville by the East Lindsey (Parishes) Order 2005 (S.I. 2005/338).

 - (f) For the ordinary day of election of councillors of local government areas, *see* section 37 of the Representation of the People Act 1983 (c.2), amended by section 18(2) of the Representation of the People Act 1985 (c.50) and section 17 of, and paragraphs 1 and 5 of Schedule 3 to, the Greater London Authority Act 1999 (c.29).

Elections for the parish of Frithville and Westville

2.—(1) Elections of all parish councillors for the parish of Frithville and Westville shall be held simultaneously on the ordinary day of election of councillors in 2007, 2011 and every fourth year after 2011(a).

(2) The term of office of every parish councillor elected on the ordinary day of election of councillors in 2007 for the parish of Frithville and Westville shall be four years.

(3) Each such parish councillor shall, unless he resigns his office or it otherwise becomes vacant, continue to hold office until the fourth day after the ordinary day of election of councillors in 2011 and the newly elected parish councillors shall come into office on the day on which their predecessors retire.

Numbers of parish councillors for the parish of Frithville and Westville

3. The number of councillors to be elected for the parish of Frithville and Westville shall be eleven.

Electoral register

4. The registration officer(b) for the district of East Lindsey shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

(a) Article 2 provides for parish elections in the parish of Frithville and Westville in 2007, 2011 and every four years after 2011 in accordance with the system of parish elections every four years, as established by section 16(3) of the Local Government Act 1972 (c.70).

(b) As to registration officers, and their duties in respect of the register of local government electors, see sections 8 to 13 of the Representation of the People Act 1983 (c.2).

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to proposals made to the Electoral Commission for electoral arrangements for the parish of Frithville and Westville, created by amalgamating the parishes of Frithville and Westville within the district of East Lindsey by the East Lindsey (Parishes) Order 2005.

The new electoral arrangements apply in respect of parish elections to be held on and after the ordinary day of election of councillors in 2007.

Article 2 provides for parish elections in the parish of Frithville and Westville in 2007, 2011 and every four years after 2011.

Article 3 specifies the number of parish councillors for the parish of Frithville and Westville.

Article 4 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.
