LOCAL GOVERNMENT ACT 1972

SECTION 74 - CHANGE OF NAME OF COUNTY, DISTRICT OR LONDON BOROUGH

1. Grimsby Borough Council - Humberside County - changed the name of the borough to Great Grimsby with effect from 1 January 1979. The title of the local authority is now Great Grimsby Borough Council.
2. The Council of the London Borough of Hammersmith changed the name of the borough to Hammersmith and Fulham with effect from 1 April 1979. The title of the local authority is now the Council of the London Borough of Hammersmith and Fulham.

ALTERATIONS TO BOUNDARIES OF LOCAL AUTHORITIES - PART IV. THE FOLLOWING BOUNDARY CHANGES CAME INTO EFFECT ON 1 APRIL 1979

DEVON

In the district of South Hams, part of the Parish of Harford has been transferred to the Parish of Ivybridge by the Harford and Ivybridge (Areas) Order(S.I. 1979 No. 90).

HAMPSHIRE

8 new parishes have been created in the District of New Forest by the New Forest (Parishes) Order (SI 1979 No 148) viz the Parishes of Hordle; Lymington and Pennington; Milford-on-Sea; and New Milton in the area of the former borough of Lymington and the Parishes of Brockenhurst; Ellingham, Harbridge and Ibsley; Hyde and Sandleheath.

In addition, the order also effects a number of other transfers between parishes within the district.
