We think the proposed changes are well argued. Where we do have doubts about new councillors being involved in for example Oldfield Brow where there is a legacy of planning still undecided it has been pointed out that by 2023 there may be new councillors from different parties.

This is an improvement on the current situation. These boundaries reflect more how local people think of their area. The one place where there is a problem is the east side around where the B5165 is shown on the map. The small area east of the A56 (Washway/Manchester Road) and north of the un-used railway line thinks of itself as being part of Timperley or West Timperley and not Broadheath. Park Road which runs through this small area is a natural link to Timperley village. The unused railway line acts as a thought barrier with resident to the north thinking either Timperley or even Sale, while those to the south think Broadheath.

To the north of this proposed Ward is Oldfield Brow. Oldfield Brow see itself as being part of Altrincham and certainly not part Bowdon. The roads run into Altrincham, as do the bus routes. The socio economics of the area are more in line with Altrincham than Bowdon. There is a wide green space between Oldfield and Bowdon. Oldfield has more in common historically with Broadheath than Bowdon. It should remain part of Altrincham. The proposed changes of moving Dunham into the Western Parishes makes a lot of sense. The residents of this area see themselves more as a rural area and not part of urban Bowdon.
