Thank you for giving us a chance to comment on the further draft recommendations in East Rushcliffe area.

1. Cropwell ward - The addition of Owthorpe into the revised Cropwell ward makes sense, this small hamlet is a close neighbour of Cropwell Bishop, residents use facilities in Cropwell Bishop.
2. Nevile and Langar ward - The 2015 Local Government Boundary Review divided the villages into 2 wards which was unpopular with electors. The parish council's strapline 'Two Villages one community' sums up the close link between the villages so the proposal to put them back in one ward is to be welcomed.
3. Cranmer ward - the proposed ward offers good electoral equality and the villages link well together. I suggest that Sutton cum Granby be referred to as Sutton cum Granby and not as Granby, the electors in Sutton are rightly proud of their hamlet. The alternative option for North-eastern Rushcliffe on page 7 for Cranmer ward would include far too many parishes, 12 in total, it would be unworkable. The ward option proposed is much better.
4. East Bridgford ward - the villages in the proposed ward would link together well.
5. Newton - Linking Upper Saxondale, Saxondale, the northern section of Cropwell Butler parish together with Newton and Shelford parishes could work, access via Oatfield Lane links the villages and avoids the need to drive through Radcliffe-on-Trent.
