Our Recommendations



arrangements



Who we are

- The Local Government Boundary Commission for England is an independent body set up by Parliament.
- We are not part of government or any political party.
- We are accountable to Parliament through a committee of MPs chaired by the Speaker of the House of Commons.
- Our main role is to carry out electoral reviews of local authorities throughout England.

Electoral review

An electoral review examines and proposes new electoral arrangements for a local authority, including:

- The total number of councillors representing the council's electors ('council size').
- The names, number and boundaries of wards or electoral divisions.
- The number of councillors for each ward or division.

Why Southampton?

- The Commission has a legal duty to carry out an electoral review of each council in England 'from time to time'.
- Southampton City Council has not been reviewed since 2000 and the Commission has therefore decided that it should review Southampton in advance of the elections in 2023.
- Southampton City Council currently has high levels of electoral inequality: some councillors represent many more - or many fewer - electors than others.
- We are seeking to improve levels of electoral equality for local electors.

Our proposals

- Southampton City Council currently has 48 councillors.
 Based on the evidence we received, we recommend that 51 councillors should serve the council in the future.
- We believe our final recommendations meet our statutory criteria to:
 - 1. Deliver electoral equality for electors
 - 2. Reflect community interests and identities
 - 3. Promote effective and convenient local government

Summary of our recommendations

We have considered all of the submissions we received during our consultation on our draft recommendations.

The final recommendations propose that Southampton City Council should have 51 councillors, three more than there are now.

Southampton should have 17 three-councillor wards, one more than there is now.

We propose to make minor amendments to the boundaries between Bargate and Bevois wards, Bevois and Portswood wards, Swaythling and Bassett wards, Harefield and Bitterne Park wards and Peartree and Sholing wards.

We also proposed to rename Bargate North to Banister & Polygon, Bargate South to Bargate and Bitterne to Thornhill. We propose all these changes based on the submissions we received.
