

Electoral review

An electoral review examines and proposes new electoral arrangements for a local authority, including:

- The total number of councillors representing the council's electors ('council size').
- The names, number and boundaries of wards or electoral divisions.
- The number of councillors for each ward or division.

Why Harlow?

- The Commission has a legal duty to carry out an electoral review of each council in England 'from time to time'.
- Harlow Council currently has high levels of electoral inequality: some councillors represent many more - or many fewer - electors than others.
- · We are seeking to improve levels of electoral equality for local electors

Our proposals

- Harlow Council currently has 33 councillors. Based on the evidence we received, we recommend that 33 councillors should serve the council in the future.
- We believe our final recommendations meet our statutory criteria to:
 - 1. Deliver electoral equality for electors
 - 2. Reflect community interests and identities
 - Promote effective and convenient local 3. government

Summary of our recommendations

We have considered all the submissions we received during our consultation on our draft recommendations.

The final recommendations propose that Harlow should have 33 councillors, the same as there are now.

Harlow should have 11 wards, the same as there are now. The boundaries of all of the existing wards should change.

The 33 councillors should represent 11 three-councillor wards across the district.


