Although St Nicholas true , (the original St Nicholas estate) is full of families struggling in poverty and deprivation, because of the latching of the more affluent chrysalis park housing area on to our original ward , the deprived families no longer qualify for the student premiums set aside by government to assist those children struggling in education , however the numbers of deprived children could be accommodated by giving back the five roads that are physically in our estate that were moved to Woodfield ward , Iona , Guildford closes , Lincoln Rd , Salisbury close , Winchester close , St Albans drive , the community still believe they are part of St. Nicholas and the St. Nicholas councillors are always first point of contact if they have any ward issues , they are angry and disappointed that they were moved to a ward outside the area.

If you look at a map of the estate you will see that the roads Salisbury close, Winchester Close and Lincoln Road are part of the original estate and part of the community. They currently sit in Woodfield ward which they are not part of or near.

The closes of Iona and Guildford although built after the original roads of St Nicholas are again part of the estate and community.

The chrysalis Park estate does not identify itself with St Nicholas at all. It is away from the estate and the residents there would not have a reason to ever visit the estate or be part of the community there.

I hope you will take my comments and concerns into consideration when looking at the ward reviews.
