

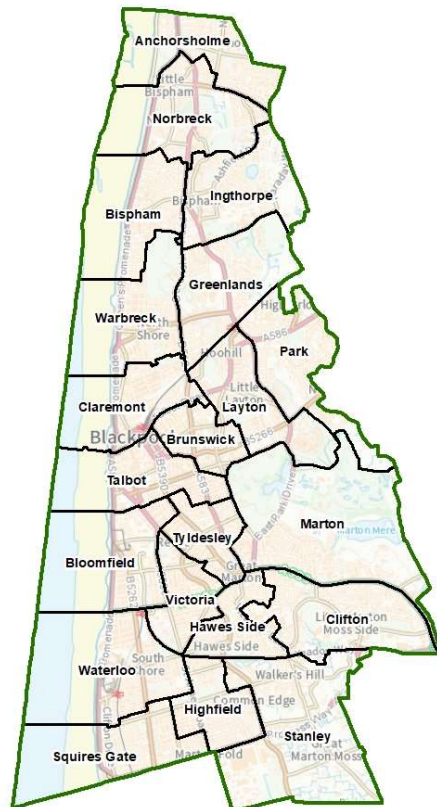
# News Release from the Local Government Boundary Commission for England

## Have your say on a new political map for Blackpool Council

New boundaries are being proposed for council wards in Blackpool Council.

The Local Government Boundary Commission wants to hear what residents and local organisations think about the proposals. A 10 week consultation on the proposals will run until 11 April 2022.

The Commission is the independent body that draws these boundaries. It is reviewing Blackpool to make sure councillors will represent about the same number of electors, and that ward arrangements will help the council work effectively.

The Commission has published proposals for changes to Blackpool. It is proposing that there should be 21 two-councillor wards, the same as current arrangements. The boundaries of most wards will change; six will stay the same.

Proposed changes include:

- Reducing the size of Stanley ward, to ensure good electoral equality
- Altering the boundary between Warbreck and Greenlands ward, in order to better reflect evidence of community identity.

Launching the consultation Professor Colin Mellors, Chair of the Commission, said:

“We want people in Blackpool to help us.

“We have drawn up proposals for new wards in Blackpool. We want to make sure these new electoral arrangements reflect communities. We also want them to be easy to understand and convenient for local people.

“Residents and local organisations can help us do that. We would like them to let us know whether they agree with our proposals before we take final decisions.

“It’s easy to get involved. Go to our website. Or you can e-mail or write to us.

“Just tell us what you think and give us some details why you think that. It’s really simple, so do get involved.”
