Have your say on a new political map for Wolverhampton City Council

New boundaries are being proposed for council wards in Wolverhampton City Council.

The Local Government Boundary Commission wants to hear what residents and local organisations think about the proposals. A 10 week consultation on the proposals will run until 6 September 2021.

The Commission is the independent body that draws these boundaries. It is reviewing Wolverhampton to make sure councillors will represent about the same number of electors, and that ward arrangements will help the council work effectively.

The Commission has published proposals for changes to Wolverhampton. It is proposing that there should be 20 wards and 3 councillors per ward. Three wards will remain the same, with changes being made to the 17 other wards.

Proposed changes include:

The Commission is recommending that the whole of Bilston Town centre should lie in Bilston North ward whilst areas to the east of the city centre will be added to St Peters ward.

Launching the consultation Professor Colin Mellors, Chair of the Commission, said:

"We want people in Wolverhampton to help us.

"We have drawn up proposals for new wards in Wolverhampton. We want to make sure these new electoral arrangements reflect communities. We also want them to be easy to understand and convenient for local people.

"Residents and local organisations can help us do that. We would like them to let us know whether they agree with our proposals before we take final decisions.

"It's easy to get involved. Go to our website. Or you can e-mail or write to us.

"Just tell us what you think and give us some details why you think that. It's really simple, so do get involved"
