

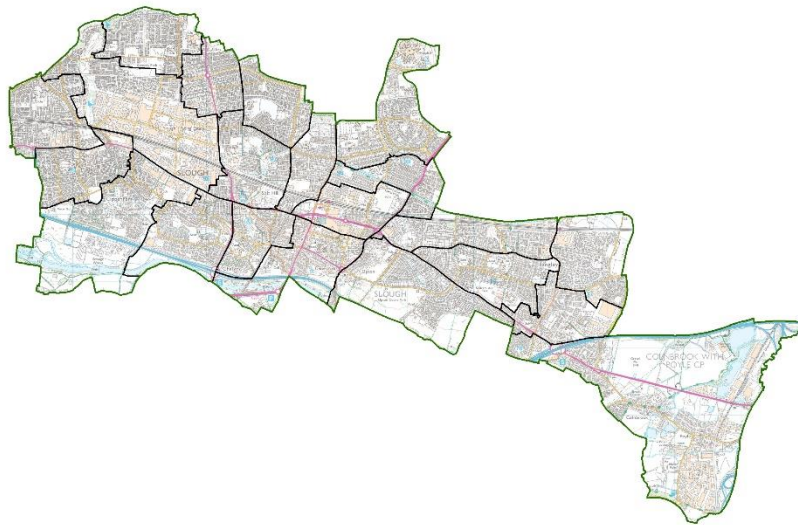
News Release from the Local Government Boundary Commission for England

Have your say on a new political map for Slough Borough Council

New boundaries are being proposed for council wards in Slough Borough Council.

The Local Government Boundary Commission wants to hear what residents and local organisations think about the proposals. A 10-week consultation on the proposals will run until 12 September.

The Commission is the independent body that draws these boundaries. It is reviewing Slough to make sure councillors will represent about the same number of electors, and that ward arrangements will help the council work effectively.

The Commission has published proposals for changes to Slough. It is proposing that there should be 21 two-councillor wards. The boundaries of all wards have been changed in these proposals.

Proposed changes include:

- The Commission is proposing Slough move from a uniform pattern of three-councillor wards to a uniform pattern of two-councillor wards.
- The Commission is also proposing the inclusion of the Goodman Park estate in Upton Lea ward instead of Slough Central.

Launching the consultation Professor Colin Mellors, Chair of the Commission, said:

“We want people in Slough to help us.

“We have drawn up proposals for new wards in Slough. We want to make sure these new electoral arrangements reflect communities. We also want them to be easy to understand and convenient for local people.

“Residents and local organisations can help us do that. We would like them to let us know whether they agree with our proposals before we take final decisions.

“It’s easy to get involved. Go to our website. Or you can e-mail or write to us.

“Just tell us what you think and give us some details why you think that. It’s really simple, so do get involved”

- Make sure that, within an authority, each councillor represents a similar number of electors
- Create boundaries that are appropriate, and reflect community ties and identities
- Deliver reviews informed by local needs, views and circumstances
