#### **Our Recommendations**



#### arrangements



#### Who we are

- The Local Government Boundary Commission for England is an independent body set up by Parliament.
- We are not part of government or any political party
- We are accountable to Parliament through a committee of MPs chaired by the Speaker of the House of Commons.
- Our main role is to carry out electoral reviews of local authorities throughout England.

#### Electoral review

An electoral review examines and proposes new electoral arrangements for a local authority, including:

- The total number of councillors representing the council's electors ('council size').
- The names, number and boundaries of wards or electoral divisions.
- The number of councillors for each ward or division.

#### Why Blackpool?

- The Commission has a legal duty to carry out an electoral review of each council in England 'from time to time'.
- Blackpool Council has not been reviewed since 2001 and the Commission has therefore decided that it should review Blackpool Council in advance of the elections in 2023.

#### Our proposals

- Blackpool Council currently has 42 councillors.
  Based on the evidence we received, we recommend that 42 councillors should serve the council in the future.
- We believe our final recommendations meet our statutory criteria to:
  - 1. Deliver electoral equality for electors
  - 2. Reflect community interests and identities
  - 3. Promote effective and convenient local government

#### **Summary of our recommendations**

We have considered all of the submissions we received during our consultation on our draft recommendations.

The final recommendations propose that Blackpool Council should have 42 councillors, the same as there are now.

Blackpool should have 21 wards, the same as there are now. The boundaries of most of the existing wards should change; six will stay the same.

The 42 councillors should represent 21 two-councillor wards across the council area.


