

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The Hinckley & Bosworth Borough Council (Reorganisation of Community Governance) Order 2023

Made - - - - 1 March 2023

Coming into force in accordance with article 1(2)

Hinckley & Bosworth Borough Council ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 1 November 2022.

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflected the identities and interests of the community and is effective and convenient.

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The council makes the following Order in exercise of the powers conferred by sections 86 and 240(10) of the 2007 Act.

1. **Citation and commencement**

- (1) This Order may be cited at the Hinckley & Bosworth Borough Council (Reorganisation of Community Governance) Order 2023.
- (2) Subject to paragraphs (3) and (4) below, this Order comes into force on 1 April 2023.
- (3) Articles 4, 5, 6, 7 and 8 shall come into force on the ordinary day of election of councillors in 2023.
- (4) For the purposes of proceedings preliminary or relating to the election of parish councillors for the parishes of Bagworth & Thornton, Kirkby Mallory, Peckleton & Stapleton, Stoke Golding and Dadlington & Sutton Cheney to be held on the ordinary day of election of councillors in 2023, this Order shall come into force on 1 February 2023.

2. Interpretation

In this Order –

“borough” means the borough of Hinckley & Bosworth

“existing” means existing on the date this Order is made

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

3. Effect of Order

This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provisions of the Order.

4. Number of parish councillors for the parish of Bagworth & Thornton:

- (1) The number of parish councillors to be elected for the parish of Bagworth & Thornton shall remain at eight as shown in schedule 1.
- (2) The number of parish councillors to be elected for the parish ward of Bagworth within the parish of Bagworth & Thornton shall increase to five as shown in schedule 1.
- (3) The number of parish councillors to be elected for the parish ward of Thornton within the parish of Bagworth & Thornton shall decrease to three as shown in schedule 1.

5. Change in name of the parish of Peckleton:

- (1) The existing parish of Peckleton shall be named Kirkby Mallory, Peckleton & Stapleton as shown in schedule 2.
- (2) The existing parish council named Peckleton Parish Council shall be named Kirkby Mallory, Peckleton & Stapleton Parish Council as shown in schedule 2.

6. Number of parish councillors for the parish of Stoke Golding:

- (1) The number of parish councillors to be elected for the parish of Stoke Golding shall increase to eight as shown in schedule 3.

7. **Change in name of the parish of Sutton Cheney:**

- (1) The existing parish of Sutton Cheney shall be named Dadlington & Sutton Cheney as shown in schedule 4.
- (2) The existing parish council named Sutton Cheney Parish Council shall be named Dadlington & Sutton Cheney Parish Council as shown in schedule 4.

8. **Number of parish councillors for the parish of Dadlington & Sutton Cheney:**

- (1) The number of parish councillors to be elected for the parish of Dadlington & Sutton Cheney shall increase to eight as shown in schedule 5.
- (2) The number of parish councillors to be elected for the parish ward of Dadlington within the parish of Dadlington & Sutton Cheney shall increase to four as shown in schedule 5.
- (3) The number of parish councillors to be elected for the parish ward of Shenton with the parish of Dadlington & Sutton Cheney shall remain at two as shown in schedule 5.
- (4) The number of parish councillors to be elected for the parish ward of Sutton within the parish of Dadlington & Sutton Cheney shall remain at two as shown in schedule 5.

9. **Electoral register**

The registration officer for the borough shall make such arrangement of, or adaption of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

10. **Order date**

1 April 2023 is the Order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

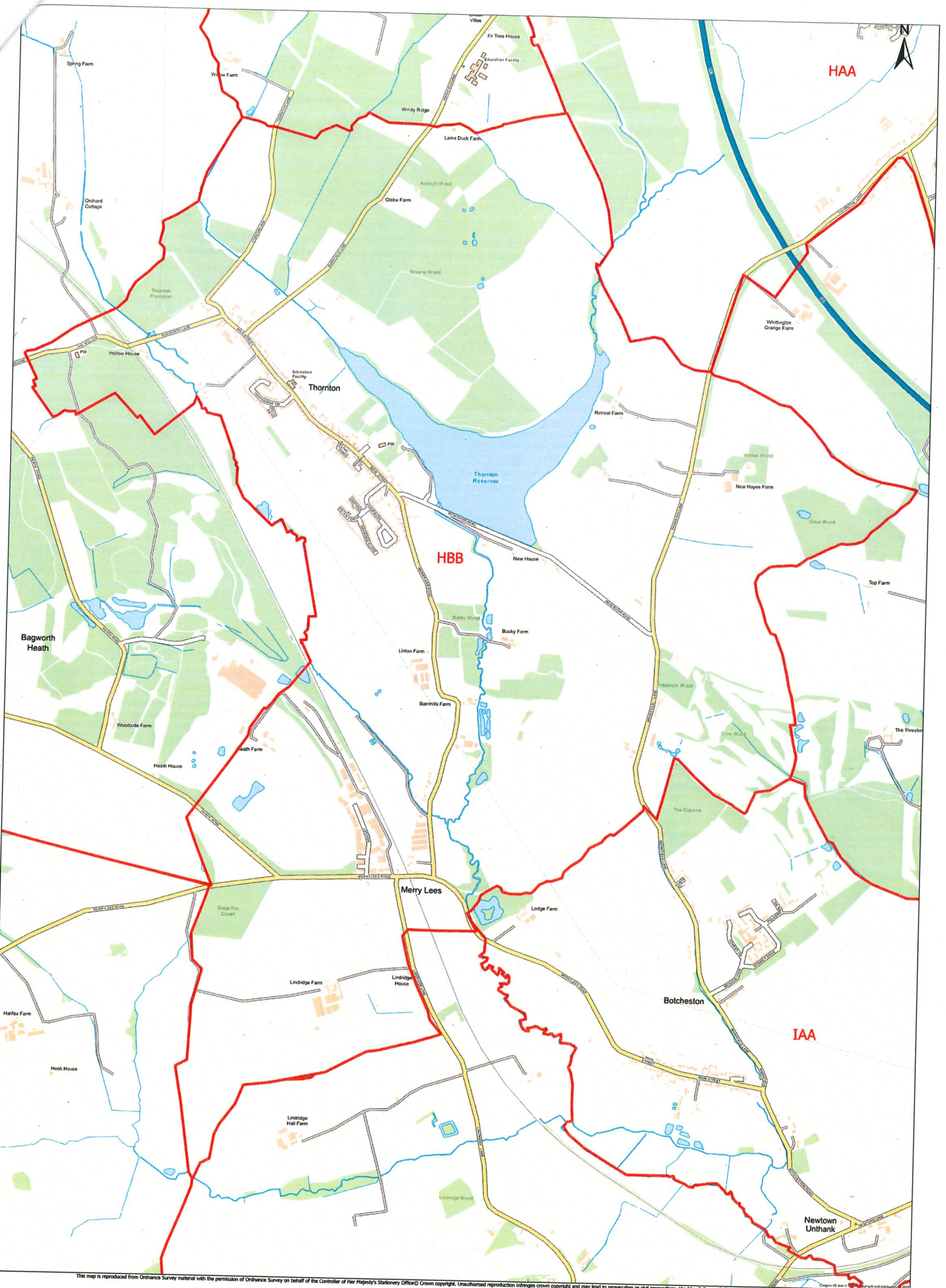

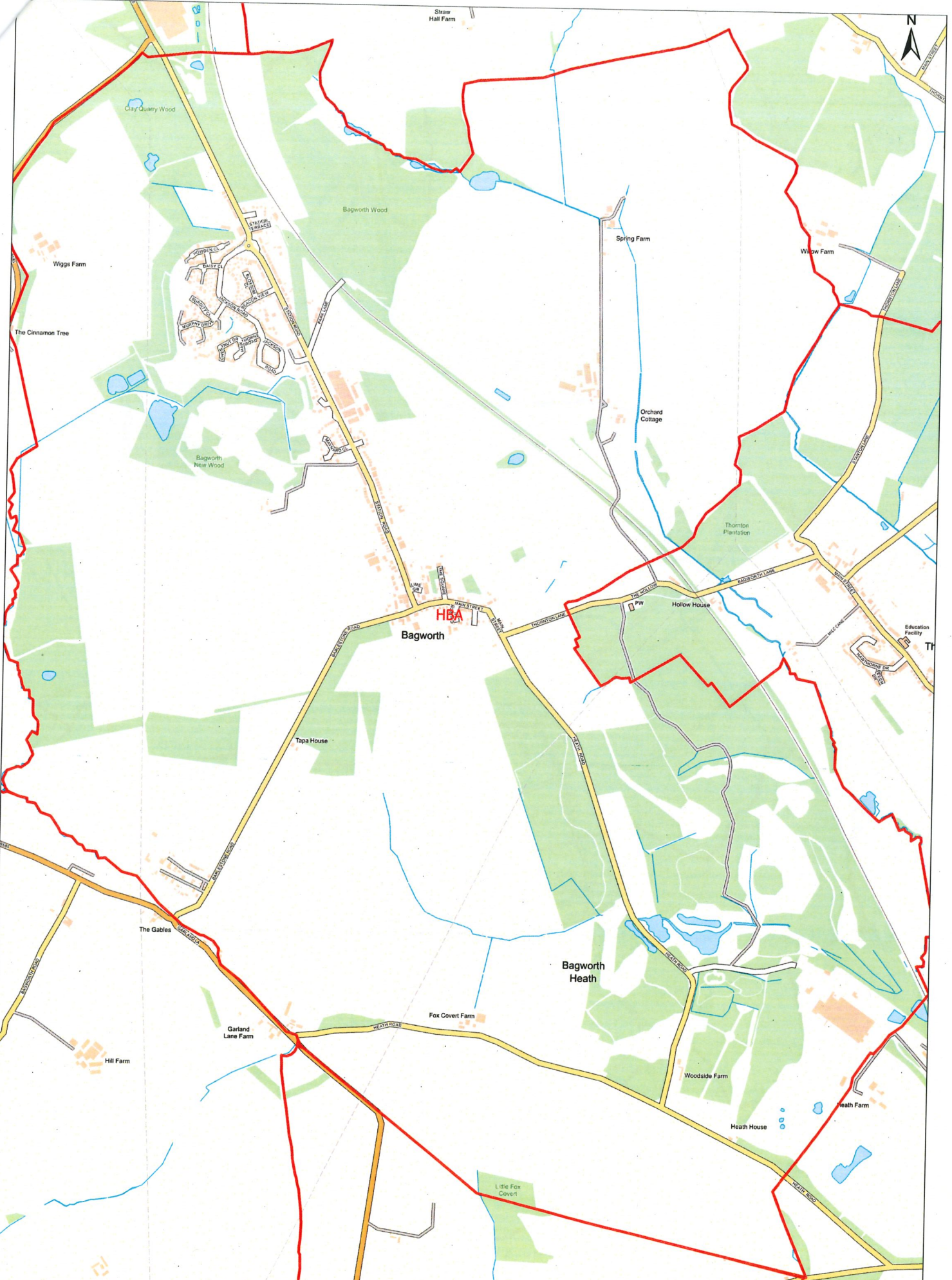

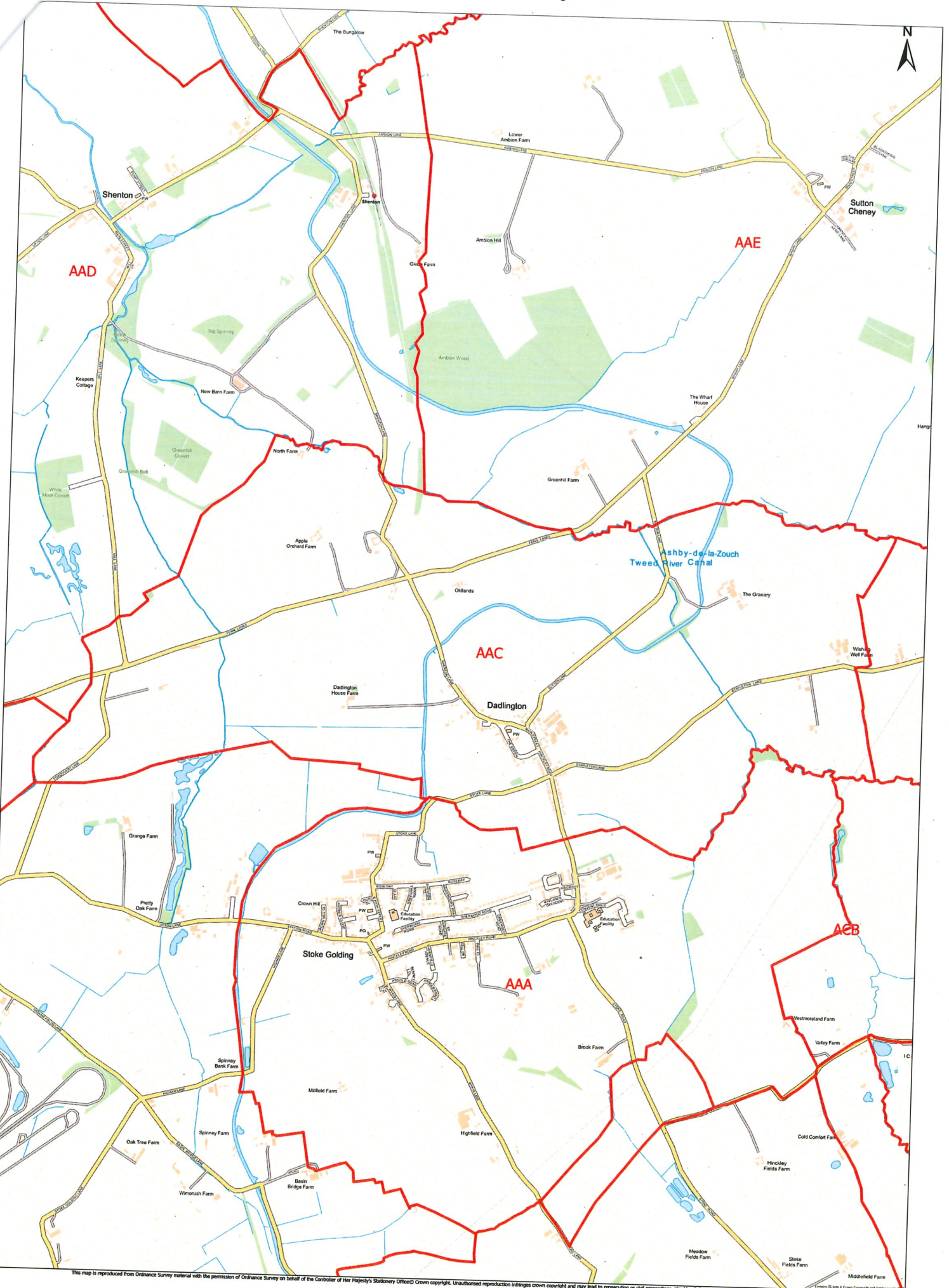
Bagworth & Thornton - Thornton



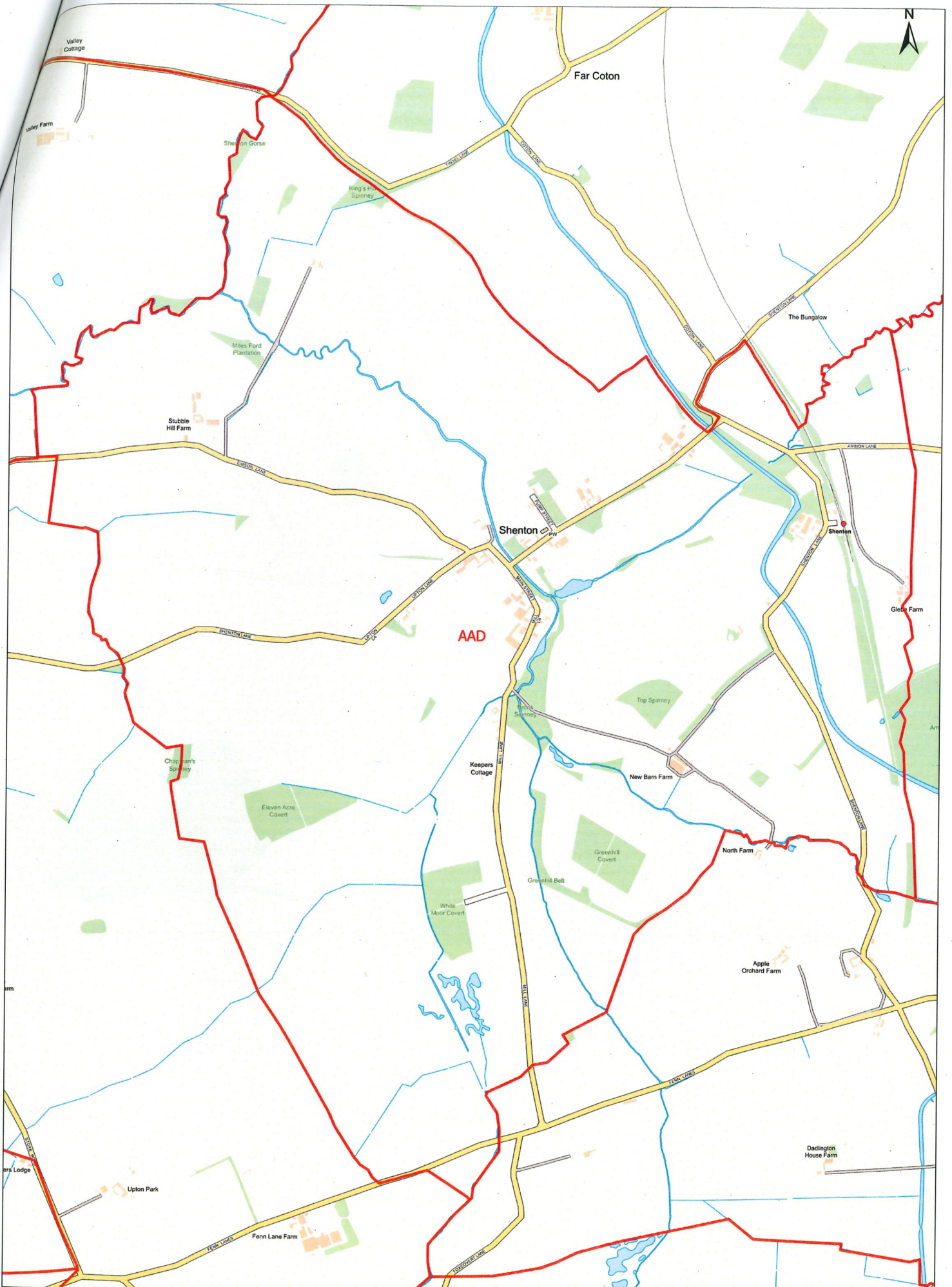
Bagworth & Thornton - Bagworth ward



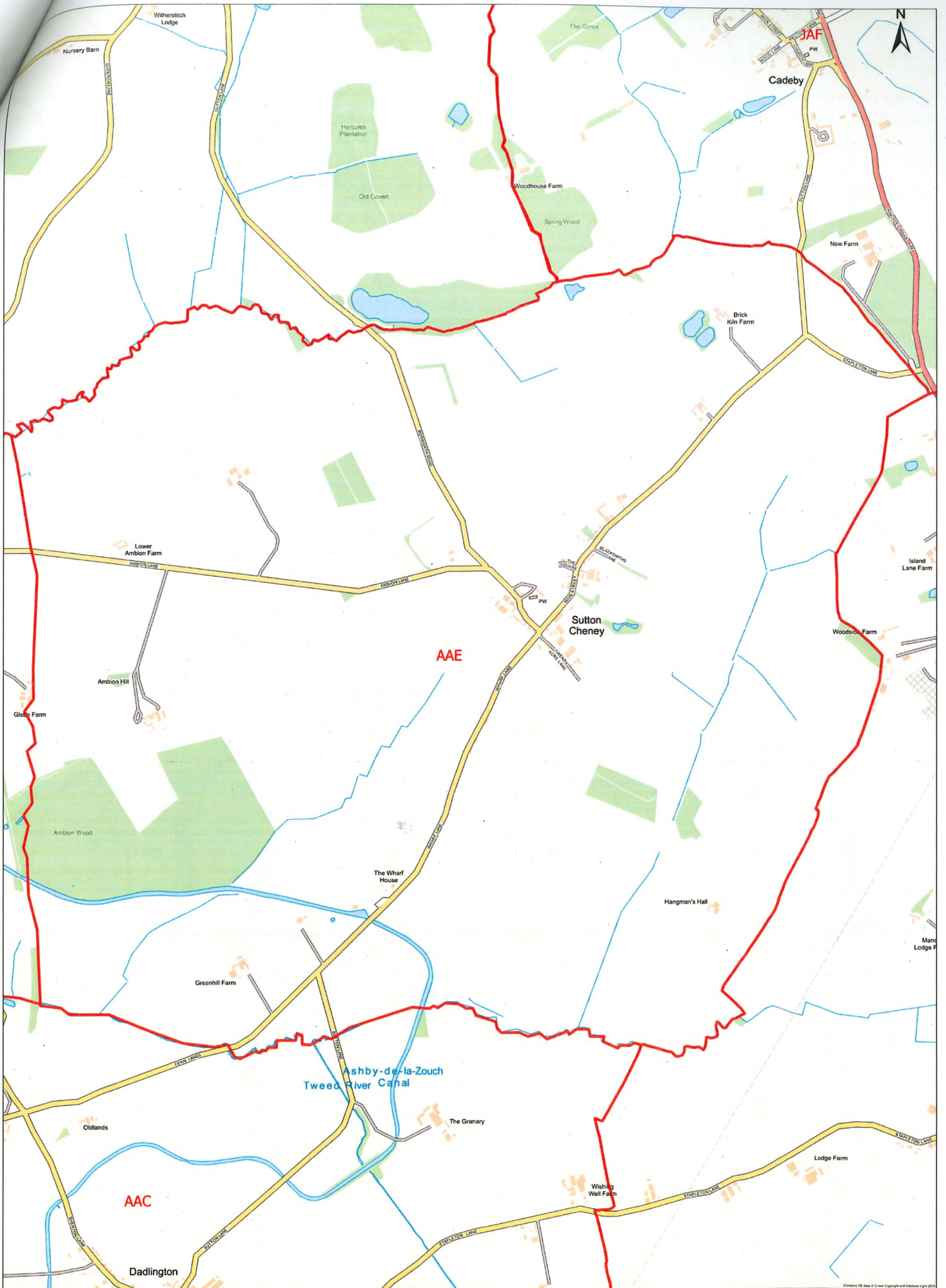
Dadlington & Sutton Cheney - Dadlington ward



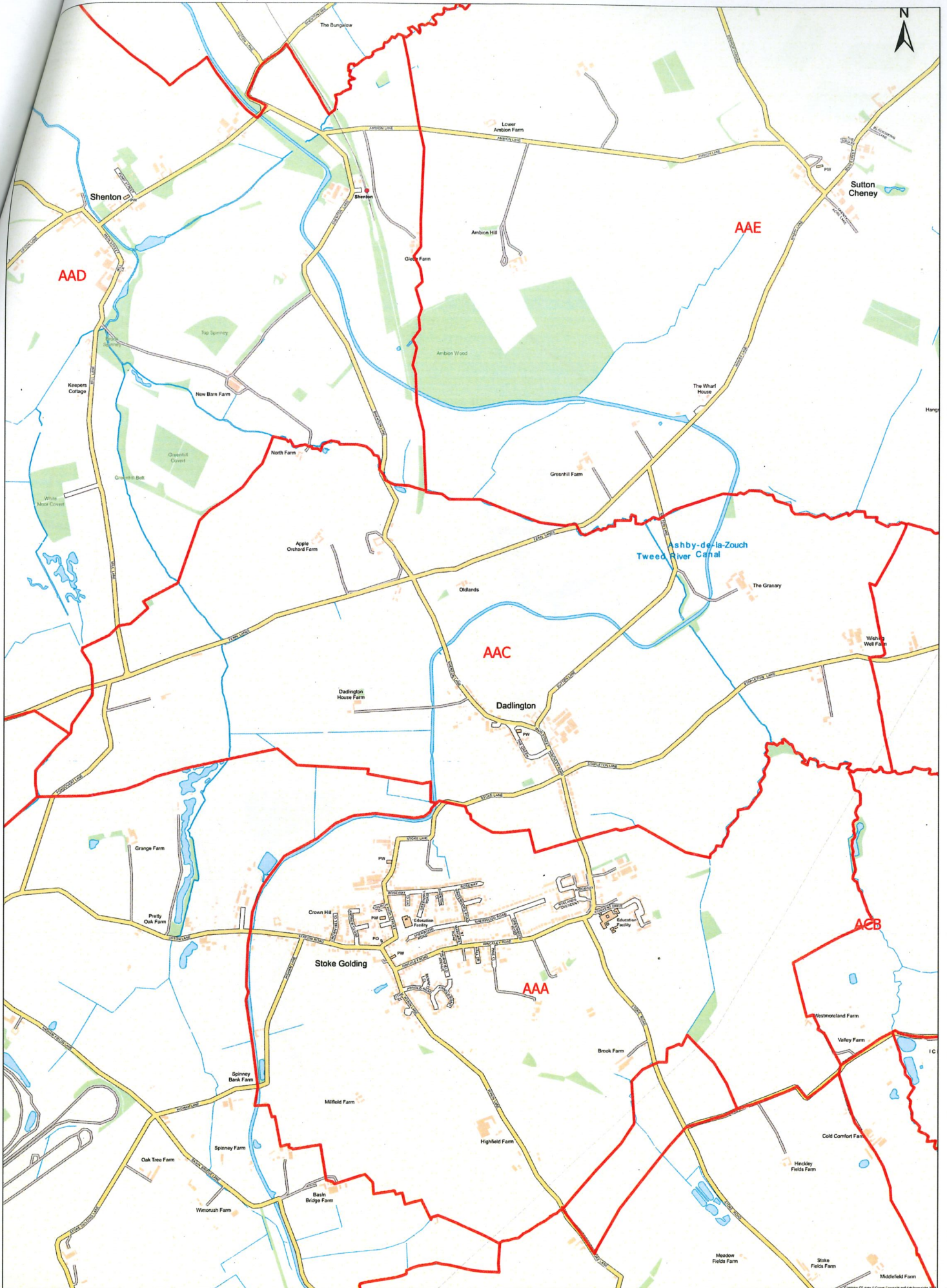
Dadlington & Sutton Cheney - Shenton ward



Dadlington & Sutton Cheney - Sutton Cheney ward

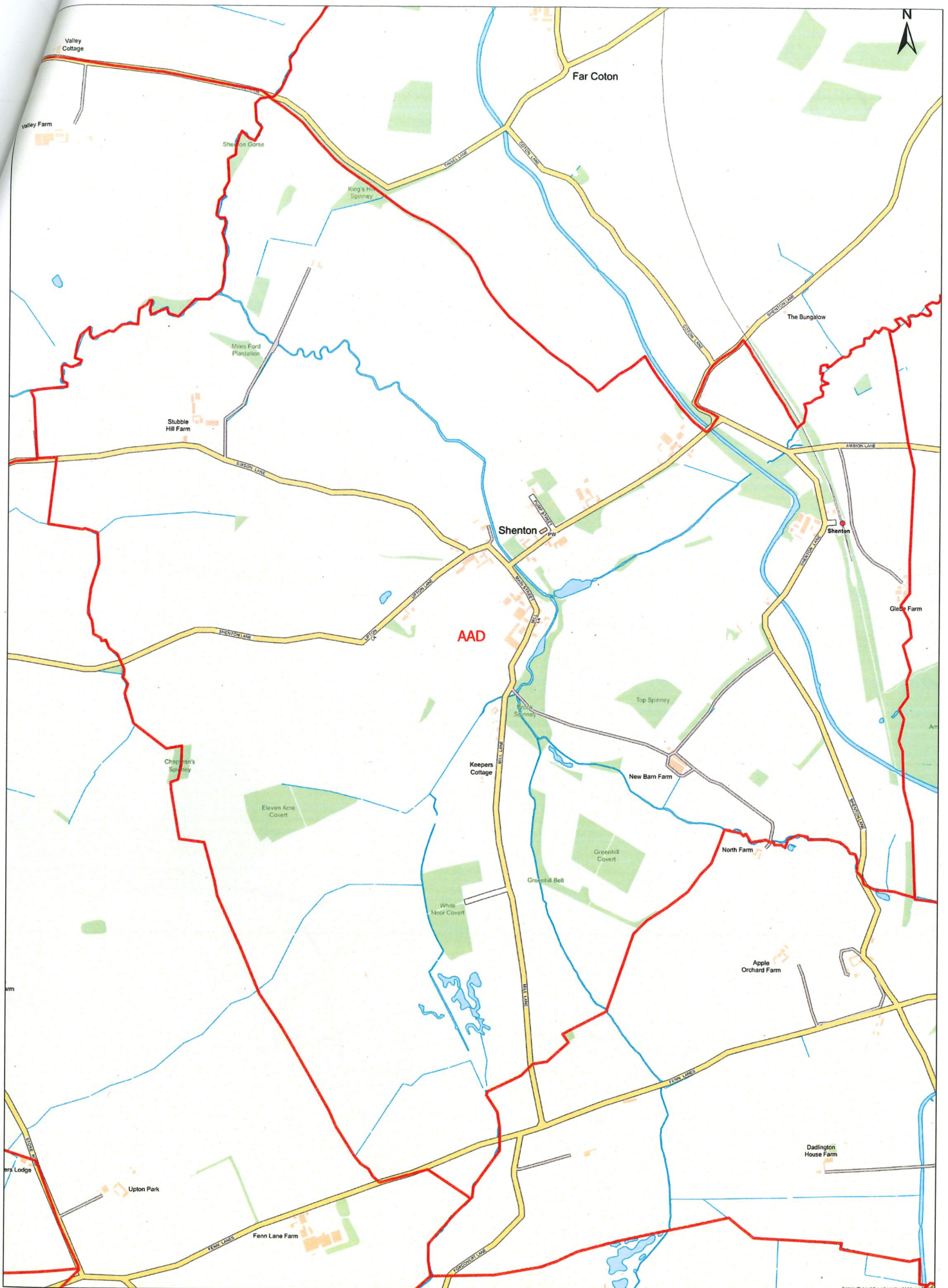


Kirkby Mallory, Peckleton & Stapleton - Kirkby Mallory ward
