**The St Albans City & District Council (Reorganisation of  
Community Governance) Order 2023**

**Supplementary Order - Amended Schedule 3**

Made ~~1st~~ **1st March 2023** Coming into force in accordance with article 1(2)

St Albans City & District Council (“the Council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 7<sup>th</sup> December 2022:

The Council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient.

The Council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section. The Council makes the following Order in exercise of the powers conferred by sections 86, 98(3), 98(4), 98(6) and 240(10) of the 2007 Act.

**Citation and commencement**

1.(1) The Order cited as the St Albans City & District (Reorganisation of Community Governance) Order 2023 should be read in conjunction with this Schedule 3 (“Amended Schedule 3”) which replaces the Schedule 3 in the original Order.

## **Effect of Order**

2.(1) This Order amends any references in St Albans City & District (Reorganisation of Community Governance) Order 2023 to “Schedule” to a reference to “Amended Schedule 3”.

(2) This Order makes no changes to the St Albans City & District (Reorganisation of Community Governance) Order 2023 other than those set out in the Amended Schedule 3.
