

# LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

## The Teignbridge District Council (Reorganisation of Community Governance) Order 2022

*Made 9<sup>th</sup> November 2022*

*Coming into force in accordance with article 1(2)*

Teignbridge District Council ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated July 2022:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section

The council makes the following Order in exercise of the powers conferred by sections 98(3) of the 2007 Act.

### **Citation and commencement**

**1. This Order may be cited as the Teignbridge District Council (Reorganisation of Community Governance) Order 2022.**

(1) It shall come into force on 1st April 2023

### **Interpretation**

2. In this Order -

"district" means the district of Teignbridge District Council;

"existing" means existing on the date this Order is made;

"map" means the map marked "Map referred to in the Teignbridge District Council (Reorganisation of Community Governance) Order 2022" and deposited in accordance with section 96(4) of the 2007 Act; and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;

"ordinary day of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983; and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

### Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

### Areas affected by the Order

4. i) Alteration of the boundary between Ogwell Parish and Newton Abbot Parish;
- ii) Increase to the number of Councillors for Coffinswell Parish from five to six;
- iii) Increase to the number of Councillors for Ideford Parish from seven to eight.

### Alteration of parish areas

5. The area coloured and marked "A" on the map shall cease to be part of the parish of Newton Abbot and College ward of that parish and shall become part of the parish of Ogwell.

(1) Each area coloured and marked "A" on the map and specified in column (1) of the Schedule shall cease to be part of the parish [and parish ward] specified in relation to that area in columns (2) and (3) of the Schedule and shall become part of the parish of Ogwell specified in relation to that area in column (4) of the Schedule.

(2) The area that ceased to be part of the parish of Newton Abbot and became part of the parish of Ogwell in consequence of the Teignbridge District Council (Reorganisation of Community Governance) Order 2022 shall cease to be part of the College ward of the parish of Newton Abbot.

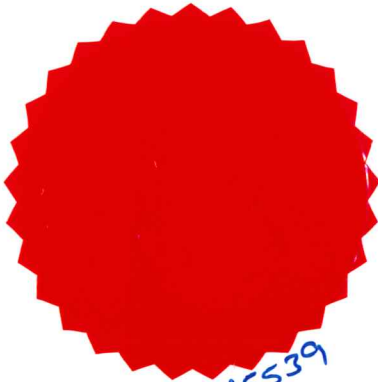
### Electoral register

6. The registration officer for the district shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

### Order date

7. 1st April 2023 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

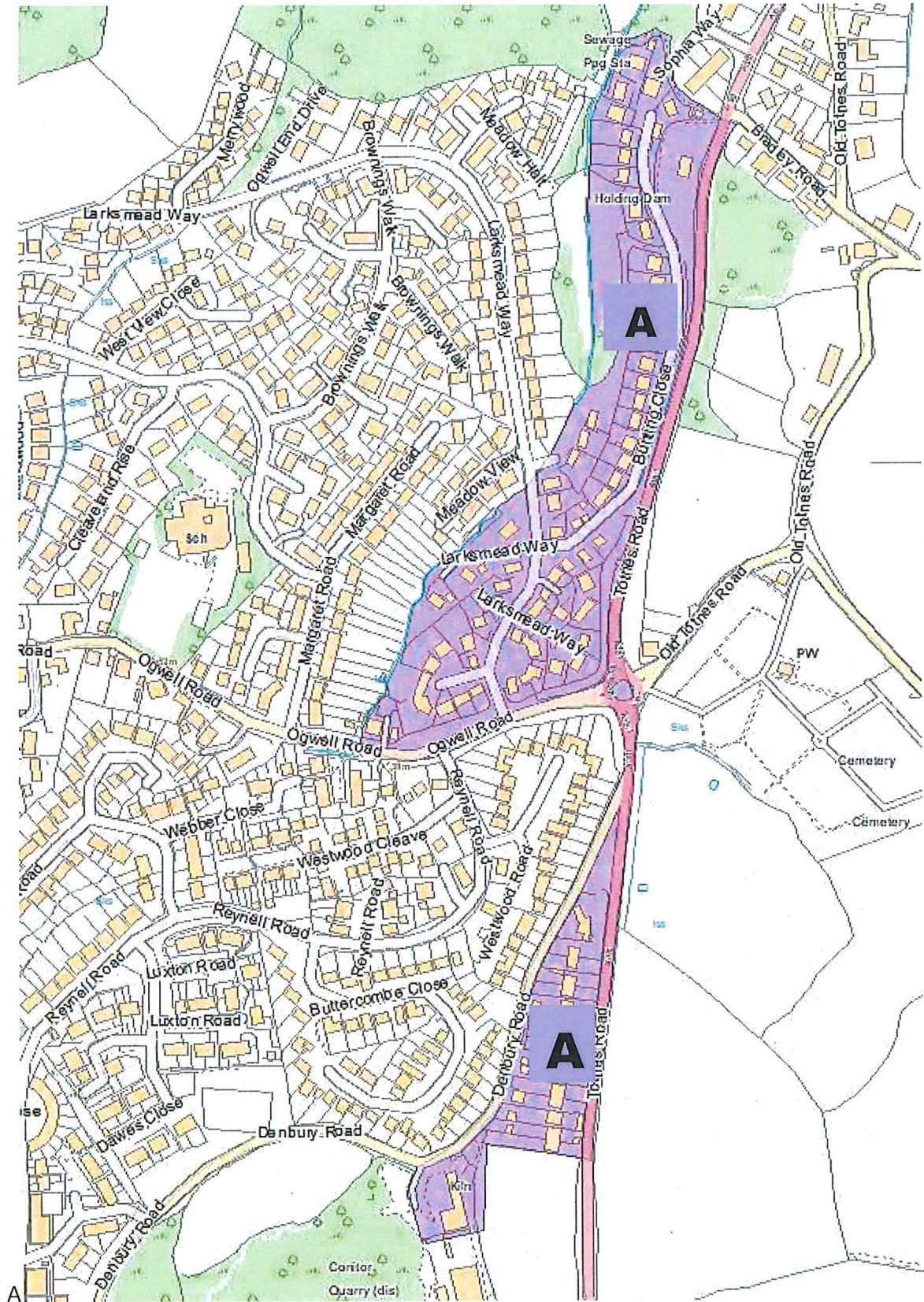
