LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The Waverley Borough Council (Reorganisation of Community Governance) Order 2023

Made - 7th Febrary 2023

Coming into force in accordance with article 1(2)

Waverley Borough Council ("the council"), in accordance with section 82(a) of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated July 2022:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by sections 86 and 240(10) of the 2007 Act.

Citation and commencement

- 1.1 This Order may be cited as the Waverley Borough Council (Reorganisation of Community Governance) Order 2023.
- 1.2 Subject to paragraph 1.3 below, this Order comes into force on 1st April 2023.
- 1.3 Articles 4 6 7 and 8 shall come into force on the ordinary day of election of councillors in 2023.

Interpretation

2.1 In this Order

"borough" means the borough of Waverley Borough Council;

"Borough Order" means the Waverley (Electoral Changes) Order 2022 SI 2022 No. 1136

"existing" means existing on the date this Order is made;

"map" means the map marked "Map referred to in the Waverley (Reorganisation of Community Governance) Order 2023" and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that letter;

"ordinary day of election of councillors" has the meaning given by section 37 of the Representation of the People Act 1983; and

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8(c) of the Representation of the People Act 1983.

Effect of Order

3.1 This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Number of parish councillors for the parish of Alford

Alfold

4.1 The number of councillors to be elected for the parish of Alford shall be nine.

Wards of the parish of Cranleigh and numbers of parish councillors

- 5.1 The existing wards of the parish of Cranleigh shall be abolished.
- 5.2 The parish shall be divided into two wards which shall be named Cranleigh East and Cranleigh West.
- 5.3 Each ward shall comprise the area of the borough ward bearing the same name.
- 5.4 The number of councillors to be elected for Cranleigh East ward shall be seven, and for Cranleigh West ward shall be five.

Wards of the parish of Farnham and numbers of parish councillors

- 6.1 The existing wards of the parish of Farnham shall be abolished.
- 6.2 The parish shall be divided into eight wards which shall be named as set out in column (1) of Schedule 1.
- 6.3 Each ward shall comprise the area of the borough ward specified in respect of the ward in column (2) of that Schedule.
- 6.4 The number of councillors to be elected for each ward shall be two.

Wards of the parish of Godalming and numbers of parish councillors

- 7.1 The existing wards of the parish of Godalming shall be abolished.
- 7.2 The parish shall be divided into five wards which shall be named as set out in column (1) of Schedule 2.
- 7.3 Each ward shall comprise the area of the borough ward specified in respect of the ward in column (2) of that Schedule.
- 7.4 The number of councillors to be elected for each ward shall be the number specified in respect of the ward in column (3) of that Schedule.

Alteration of parish areas

8.1 Each area coloured and designated by a letter on the map and specified in column (1) of the Schedule shall cease to be part of the parish specified in relation to that area in column (2) of the Schedule and shall become part of the parish specified in relation to that area in column (3) of the Schedule.

Change of parish name

- 9.1 The parish of Busbridge shall be named Munstead and Tuesley.
- 9.2 The parish of Witley shall be named Witley and Milford.

Electoral register

10.1 The registration officer for the borough shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Order date

11.1 1st April 2023 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.
