

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order [2023]

Coming into force in accordance with article 1(2)

Mid Devon District Council ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 23 November 2022.

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient.

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section.

The council makes the following Order in exercise of the powers conferred by section 86 and 240(10) of the 2007 Act.

Citation and commencement

- 1.—(1) This Order may be cited as the Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order 2023.
- (2) Subject to paragraph 3 below, this Order comes into force on 1 May 2023

Interpretation

2. — In this Order—

"Map 1" means the map marked "Map 1" referred to in the Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order 2023

"Map 2" means the map marked "Map 2" referred to in the Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order 2023

"Map 3" means marked "Map 3" referred to in the Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order 2023".

"registration officer" means an officer appointed for the purpose of, and in accordance with, section 8(c) of the Representation of the People Act 1983.

Effect of Order

- 3.— This Order has effect subject to any agreement under section 99 of the 2007 Act (agreements about incidental matters) relevant to any provision of this Order.

Alteration of Parish areas

- 4.—Hittisleigh Parish Council shall now include the area marked as "A" on Map 1 comprising of West Ford Farm, along the river to the lane beneath West Fursham Farm including West Fursham, East Fursham and Easton Barton meeting at Fursham Cross; and the areas marked as "B" and "C" on Map 2 comprising of the easterly direction from Hittisleigh Mill, running up the Yeo River to Binneford, continuing up the lane to meet the lane from Yeoford, turning left and then right down Road Down Lane and meeting the existing boundary below Road Down Farm. Including the properties on the eastern side namely East Church Farm, Shortridge Farm, Trevince, Binneford House, Binneford Farm, Binneford Studio, Summer Corner, East Binneford Farm, Summerhill Farm, Woodside Bungalow and Road Down Farm.

The area marked as "D" on Map 3 comprising of The Orchard shall cease to be a part of Hittisleigh Parish.


Electoral register

- 5.—The registration officer for the council shall make such rearrangement of, or adaptation to, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Order date

- 6.—1 May 2023 is the Order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

Map 1 referred to in the Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order 2023

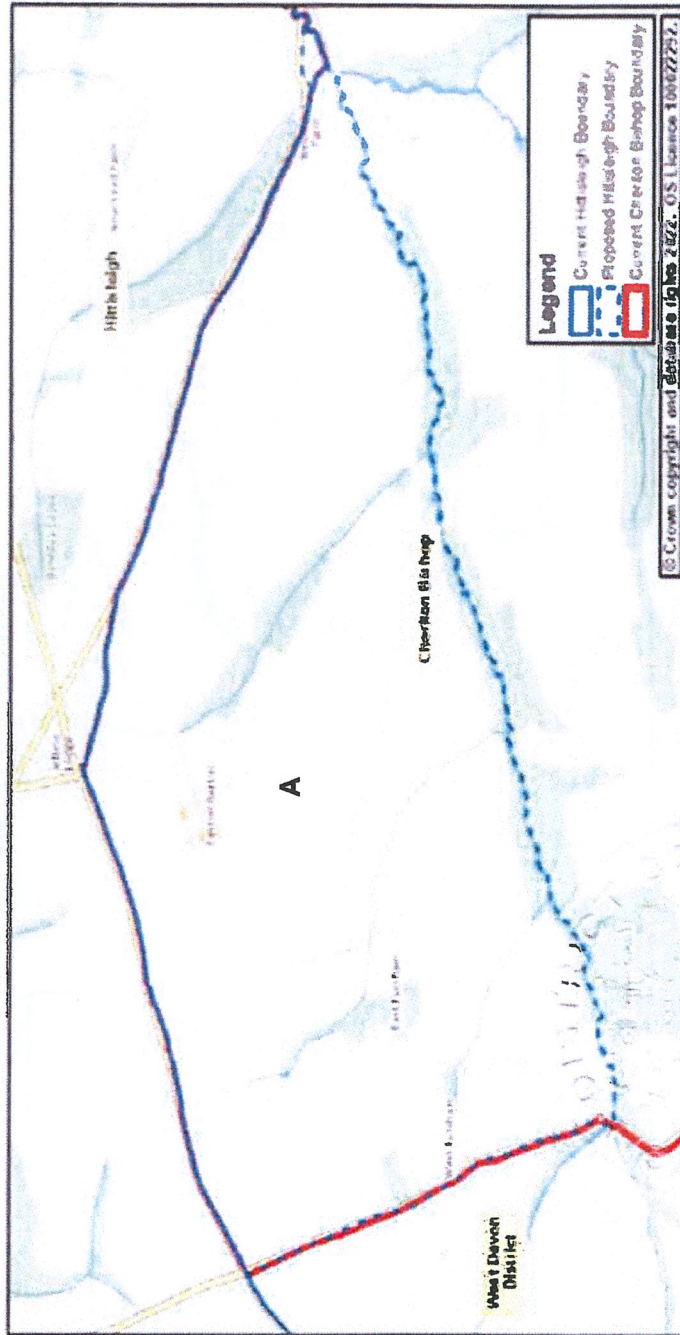

Map 2 referred to in the Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order 2023

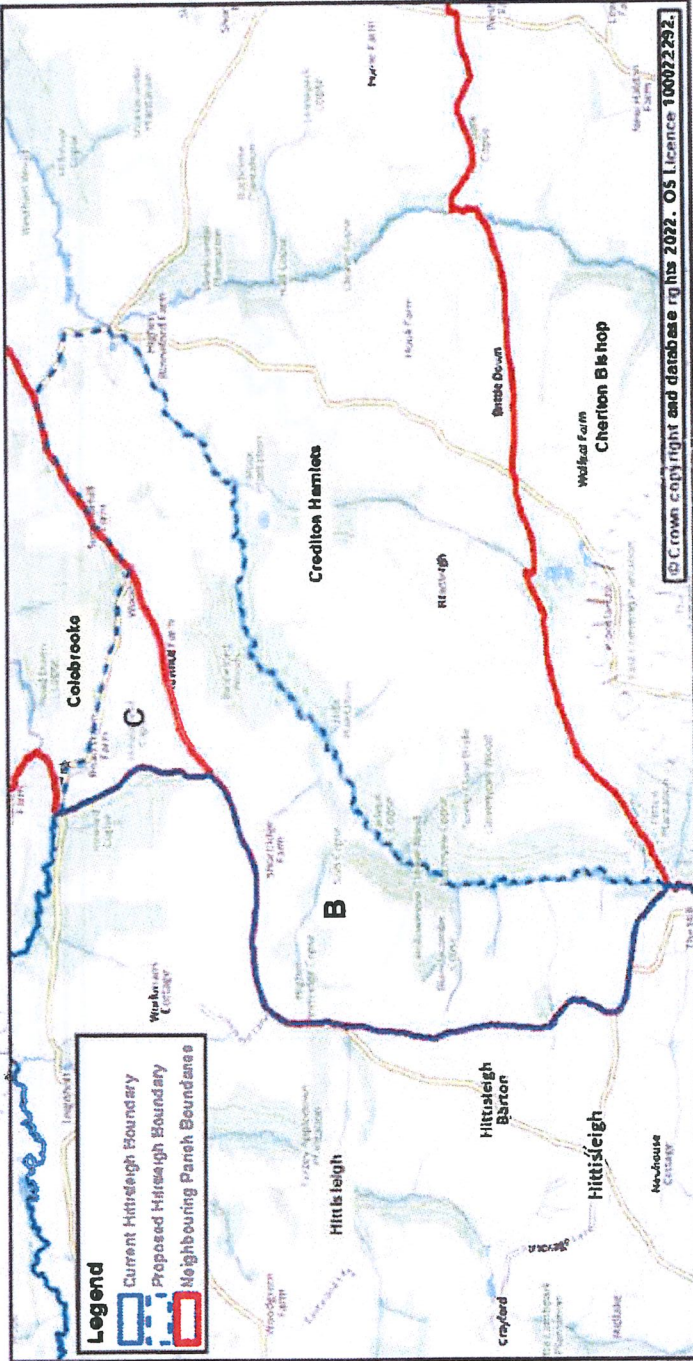

Map 3 referred to in the Mid Devon District Council (Reorganisation of Community Governance) (Hittisleigh Parish Council) Order 2023

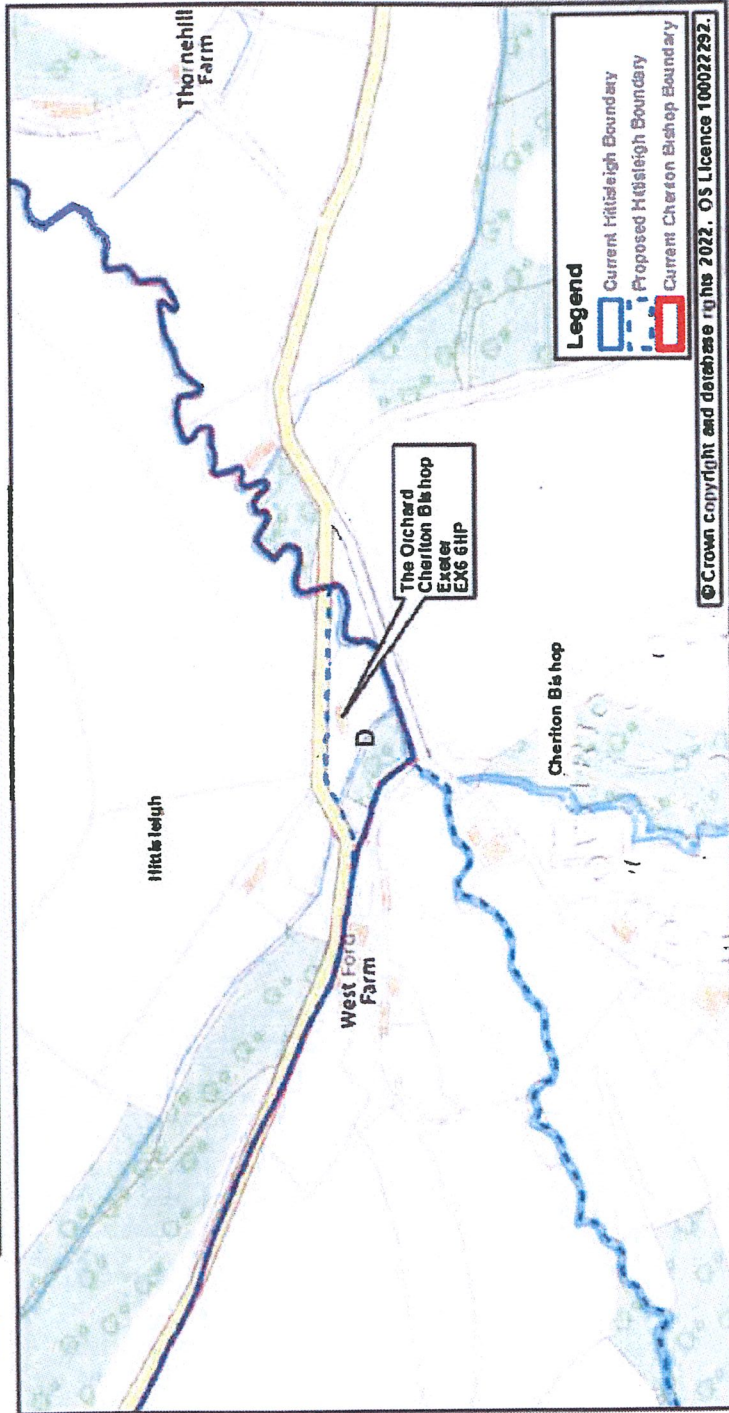
