

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The District of Cotswold (Reorganisation of Community Governance) (Amendment) Order 2023 No.2

Made: 13th April 2023

Coming into force in accordance with article 1(2)

Cotswold District Council (“the Council”), having undertaken a community governance review in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), and made recommendations dated 25th of May 2022.

The Council decided to give effect to those recommendation and made the District of Cotswold (Reorganisation of Community Governance) Order 2022 and the District of Cotswold (Reorganisation of Community Governance) (Amendment) Order 2023 in exercise of the powers conferred by Sections 86, 98(3), 98(4), 98(6) and 240(10) of the 2007 Act.

The Council considers it is necessary to vary the District of Cotswold (Reorganisation of Community Governance) Order 2022 in exercise of the powers conferred by Section 86(5) of the 2007 Act.

The Council makes the following Order in exercise of the power conferred by Section 86(5) of the 2007 Act.

Citation and commencement(a)

1.—(1) This Order may be cited as the District of Cotswold (Reorganisation of Community Governance) (Amendment) Order 2023 No.2 (“the Amendment Order No.2”)

(2) It shall come into effect the day after the Amendment Order No. 2 is made.

Interpretation

2. —In this Order—

“the Amendment Order No. 2” means this Order;

Further Amendments

3.—(1) The District of Cotswold (Reorganisation of Community Governance) Order 2022 shall be amended in accordance with paragraphs (2), (3) and (4)

(2) After Article 1(3A) there shall be inserted—

“(3B) Article 13A shall come into force:

(a) for proceedings preliminary or relating to the election of councillors on 14th April 2023 and

(b) for all remaining purposes on the Ordinary Day of Election of Councillors in 2023.”

(3) After Article 13 there shall be inserted—

“13A. —Brimpsfield

(1) The area coloured purple and designated by the letter “D” on the map shall cease to be part of the parish of Brimpsfield and shall become part of the parish of Birdlip.”

(4) After the map designated by the letter “C” there shall be included the following map designated by the letter “D”


