

Who we are

- The Local Government Boundary Commission for England is an independent body set up by Parliament.
- Tunbridge Wells Borough Council has not been • We are not part of government or any political reviewed since 2001 and the Commission has party. therefore decided that it should review Tunbridge committee of MPs chaired by the Speaker of the Wells in advance of the elections in 2024.
- We are accountable to Parliament through a House of Commons.
- Our main role is to carry out electoral reviews of local authorities throughout England.

Electoral review

An electoral review examines and proposes new electoral arrangements for a local authority, including:

- The total number of councillors representing the council's electors ('council size').
- The names, number and boundaries of wards or electoral divisions.
- The number of councillors for each ward or division.

Why Tunbridge Wells?

 The Commission has a legal duty to carry out an electoral review of each council in England 'from time to time'.

Our proposals

- Tunbridge Wells Borough Council currently has 48 councillors. Based on the evidence we received. we recommend that 39 councillors should serve the council in the future.
- We believe our final recommendations meet our statutory criteria to:
 - 1. Deliver electoral equality for electors
 - 2. Reflect community interests and identities
 - 3. Promote effective and convenient local government

Summary of our recommendations

We have considered all the submissions we received during our consultation on our draft recommendations.

The final recommendations propose that Tunbridge Wells should have 39 councillors, a decrease of 9.

Tunbridge Wells should have 14 wards, a decrease of 6. The boundaries of all of the existing wards should change.

The 39 councillors should represent twelve three-councillor wards, one two-councillor ward and one one-councillor ward across the borough.


