Overview

The Local Government Boundary Commission for England (LGBCE) called for a review of Dudley Metropolitan Borough Council as 20 years had elapsed since our last review. One of the aims of the LGBCE review is to create 'electoral equality', where the number of electors per councillor is as even as possible, ideally within 10% of being exactly equal.

The LGBCE has already agreed to the Council's proposal that the number of wards and ward members should remain at the current levels (24 wards and 72 councillors) as this ensures the Council is able to carry out its roles and responsibilities effectively.

The LGBCE therefore has invited proposals for new ward patterns that would be represented by 72 councillors. All such proposals need to be made to the Commission by 15th March 2023. The commission listens to all proposals and proposals can be made by members of the public, political groups, community groups etc.

As part of the process a working group of Council officers have put forward a submission of proposed ward boundary changes.

This submission has taken the following criteria into account regarding proposed boundary changes:

- Any identifiable extant communities
- Existing locally recognised community boundaries
- The projected 2028 electorate and the effect this will have on 'electoral equality' going forward
- Notable geographical features that form natural boundaries

Using the 2028 projected figures agreed by the LGBCE only Castle and Priory Ward falls outside of the 10% preferred margin (See table below).

It was the work group's opinion that the vast majority of existing wards already had clearly defined local boundaries either demarcated by obvious geographical features or well-established historic community borders. Additionally, the fact that nearly the entirety of the wards all sit comfortably within the allowed variance, meant that in large parts there is no real requirement to alter the majority of ward boundaries.

Changes

Castle and Priory Ward —————> Upper Gornal and Woodsetton Ward

Castle and Priory Ward sits outside the allowed electoral population variance both currently and in the projected 2028 population figures.

In order to bring the ward into alignment it was necessary to move around 1500 electors out of the ward.

The estate sitting south of the Sedgley Road/Sedgley Road West comprising Foxyards Road and the roads off it have a population of around 1000 electors. This area sits across the busy Birmingham New Road A4123 essentially uncoupling it from the rest of the Castle and Priory Ward.

We suggest that the 'Foxyards Estate' south of the Sedgley Road/Sedgley Road West be moved to the adjoining Upper Gornal and Woodsetton Ward with which it shares a contiguous border. It also follows the pattern of the southern section of Upper Gornal and Woodsetton Ward being oriented along the Sedgley Road/Sedgley Road West axis.

Castle and Priory Ward —————> Coseley East Ward

The properties that lie on the northern side Sedgley Road/Sedgley Road West and the land south of Bean Road (projected to be around 500 electors) should be folded into the Coseley East Ward. This area has planning for new residential development that will be partially placed on the site of the old Bean Motor Cars factory which has historic associations with Coseley and Tipton. Again, the main Sedgley road forms a natural border to the ward.

Upper Gornal and Woodsetton Ward —————▶ Sedgley Ward

The section of Dudley Road (A459) to the north of Clarence Road along with roads off including The Ridgeway (774 electors) should be moved to Sedgley as the Dudley Road forms a natural boundary between Upper Gornal and Woodsetton and sits on the same elevated plateau as the rest of Sedgley. The Ridgeway and Dudley Road also surround the perimeter of Coronation Gardens a small park associated with Sedgley.





