

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The Dorset Council (Reorganisation of Community Governance) Order [No.11] (Pamphill and Shapwick and the Vale of Allen) 2023

Made 30th June 2023
Coming into force in accordance with article 1(2)

DORSET COUNCIL ("the council"), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and made recommendations dated 11 May 2023:

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by sections 86, 98(3), 98(4), 98(6) and 240(10) of the 2007 Act.

Citation and commencement

1. (1) This Order may be cited as the Dorset Council (Reorganisation of Community Governance) Order [No.11] (Pamphill and Shapwick and the Vale of Allen) 2023.

(2) Subject to paragraph (3) below this Order shall come into force on 1 April 2024.

(3) For the purposes of:

(a) this article; and

(b) proceedings preliminary or relating to the elections of parish councillors for the parishes of Gussage All Saints, Gussage St Michael, Hinton, Crichel, Witchampton, Pamphill and Shapwick to be held on the ordinary day of election of councillors in 2024,

this Order shall come into force on the day after that on which it is made.

Interpretation

2. In this Order—

"district" means the district of Dorset;

"existing" means existing on the date this Order is made;

"map" means the map marked "Map referred to in the Dorset Council (Reorganisation of Community Governance) Order [No.11] (Pamphill and Shapwick and the Vale of Allen) 2023" and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a

numbered sheet is a reference to the sheet of the map which bears that number;

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983; and

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8 of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Parish elections

4. In accordance with section 40 of the Bournemouth, Dorset, and Poole (Structural Changes) Order 2018:

(1) Elections of all parish councillors for the parishes Gussage All Saints, Gussage St Michael, Hinton, Cricchel, Witchampton, Pamphill and Shapwick shall be held simultaneously on the ordinary day of election of councillors in 2024.

(2) The term of office of every parish councillor elected on the ordinary day of election of councillors in 2024 shall be five years, and thereafter from the ordinary day of election in 2029 shall be four years.

Alteration of parish areas

5. Each area coloured and designated by a letter on the map and specified in column (1) of Schedules 1A and 1B shall cease to be part of the parish area specified in relation to that area in columns (2) and (3) of the Schedule and shall become part of the parish specified in relation to that area in columns (4) and (5) of the Schedule.

Electoral register

6. The registration officer for the district shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Transfer of property, rights, and liabilities

7. The land, property, rights, and liabilities described in Schedules 2, 3, 4 and 5 shall transfer on the date specified in column (2) of those Schedules.

Order date

8. 1st April 2024 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

EXPLANATORY NOTE

(This note is not part of the Order)

This Order gives effect to recommendations made by Dorset Council for the alteration of the area of the parishes of Hinton, Witchampton and Pamphill within the district of Dorset.

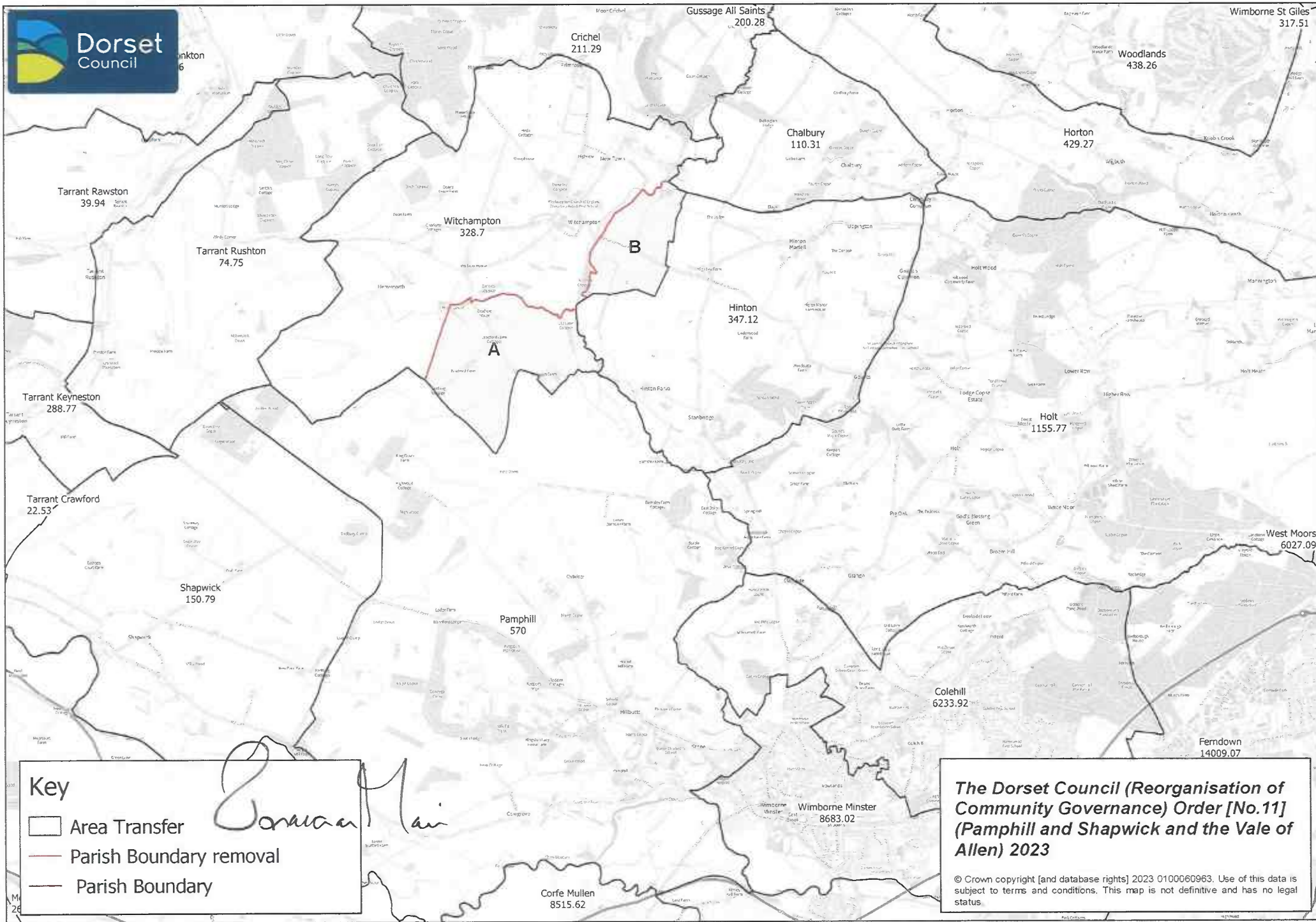
The electoral arrangements apply in respect of parish elections to be held on and after the ordinary day of election of councillors in 2024.

Article 4 provides for parish elections in the parishes of Gussage All Saints, Gussage St Michael, Hinton, Crichel, Witchampton, Pamphill and Shapwick in 2024 for a term of five years and then from 2029 to continue according to the established system of parish elections every four years.

Article 5 and the map establish the revised areas of the parishes of Hinton, Witchampton and Pamphill.

Article 6 obliges the Electoral Registration Officer to make any necessary amendments to the electoral register to reflect the new electoral arrangements.

The map defined in Article 2 shows the alteration to the areas of the of Hinton, Witchampton and Pamphill. It is available, at all reasonable times, at the offices of Dorset Council.
