Stratford-on-Avon District Council ("the Council"), in accordance with section 85 of the Local Government and Public Involvement in Health Act 2007 ("the 2007 Act"), has undertaken a community governance review and has made The Stratford-on-Avon (Reorganisation of Community Governance – Parishes of Great Wolford and Little Wolford) Order 2023.

The Council makes the following Order in exercise of the powers conferred by sections 86(5), 98(3), 98(4), 98(5) and 240(10) of the 2007 Act and Section 11 of the Local Government Act 1972.

# 1. Citation and commencement

- (1) This Order may be cited as "The Stratford-on-Avon (Reorganisation of Community Governance Parishes of Great Wolford and Little Wolford) (Amendment No. 1) Order 2023".
- (2) This Order shall come into force on 26 April 2023 and shall be effective from the Ordinary day of Election of Councillors on 4 May 2023.

# 2. Interpretation

In this Order-

"Ordinary Day of Election of Councillors" has the meaning given by section 37 of the Representation of the People Act 1983;

#### 3. Effect of Order

This Order has effect subject to any agreement under Section 99 (agreements about incidental matters) of the 2007 Act relevant to any provision of this Order.

## 4. Transfer of property, rights and liabilities

Article 10 of the Stratford-on-Avon (Reorganisation of Community Governance – Parishes of Great Wolford and Little Wolford) Order 2023 shall be deleted and replaced with the following:

(10) The land, property, rights and liabilities described in column (1) of Schedule 2 shall transfer from the Great Wolford Parish Council to The Wolfords Joint Parish Council on the date specified in column (2) of Schedule 2.

#### 5. Amendments to Schedules

- (1) The Schedule in the Stratford-on-Avon (Reorganisation of Community Governance Parishes of Great Wolford and Little Wolford) Order 2023 shall be renamed "Schedule 1".
- (2) The following shall be inserted as Schedule 2 to The Stratford-on-Avon (Reorganisation of Community Governance Parishes of Great Wolford and Little Wolford) Order 2023:
