INTRODUCTION VOTE ON ACCOUNT FOR 2024-25

Paragraph 11 of Schedule 1 to the Local Democracy, Economic Development and Construction Act 2009 requires the Local Government Boundary Commission for England to submit to the Speaker's Committee each financial year an estimate of the Commission's income and expenditure. After concluding its examination and making modifications (if any) to the estimate the Speaker's Committee shall lay the estimate before the House of Commons.

The Vote on Account provides finance to allow existing services to continue during the early months of the coming financial year, pending Parliament's consideration of the Local Government Boundary Commission for England's Estimate for 2024-25.

The Vote on Account is presented in resource, capital, and cash terms. The amounts are 45% of the amounts for the 2023-24 budget for the Local Government Boundary Commission for England, which equates to 45% of the 2023-24 provision to date, as shown in the schedule. These should be sufficient to ensure that funding is not exhausted before the Supply and Appropriation Act is passed in the summer, but not so high as to prejudge Parliament's consideration of the main Supply Estimate.

This Vote of Account together with those for the Electoral Commission, House of Commons Administration, National Audit Office, Independent Parliamentary Standards Authority and for central government departments will be authorised in the Supply and Appropriation (Anticipation & Adjustments) Bill that follows presentation of the Supplementary Estimates 2023-24 and the Vote on Account, which will seek statutory authority for the issue from the Consolidated Fund of a sum equal to the Vote on Account.
