

LOCAL GOVERNMENT AND PUBLIC INVOLVEMENT IN HEALTH ACT 2007

The North East Lincolnshire Council (Reorganisation of Community Governance) Order 2024

Made 22nd May 2024

Coming into force in accordance with article 1(2)

North East Lincolnshire Council (“the council”), in accordance with section 82 of the Local Government and Public Involvement in Health Act 2007 (“the 2007 Act”), has undertaken a community governance review and made recommendations dated 14th March 2024.

The council has decided to give effect to those recommendations and, in accordance with section 93 of the 2007 Act, has consulted with the local government electors and other interested persons and has had regard to the need to secure that community governance reflects the identities and interests of the community and is effective and convenient:

The council, in accordance with section 100 of the 2007 Act, has had regard to guidance issued under that section:

The council makes the following Order in exercise of the powers conferred by sections 86, 98 and 240 of the 2007 Act.

Citation and commencement

1.—(1) This Order may be cited as the North East Lincolnshire Council (Reorganisation of Community Governance) Order 2024.

(2) It shall come into force on 1st April 2027.

Interpretation

2. In this Order—

“borough” means the borough of North East Lincolnshire;

“map” means the map marked “Map referred to in the North East Lincolnshire Council (Reorganisation of Community Governance) Order 2024” and deposited in accordance with section 96(4) of the 2007 Act: and any reference to a numbered sheet is a reference to the sheet of the map which bears that number;]

“ordinary day of election of councillors” has the meaning given by section 37 of the Representation of the People Act 1983(b); and

“registration officer” means an officer appointed for the purpose of, and in accordance with, section 8(c) of the Representation of the People Act 1983.

Effect of Order

3. This Order has effect subject to any agreement under section 99 (agreements about incidental matters) of the Local Government and Public Involvement in Health Act 2007 relevant to any provision of this Order.

Elections for Immingham Town Council

4. The elections for all councillors for the wards of Immingham Town Council shall be held on the ordinary day of election of councillors in 2027.

Number of councillors for the wards of Immingham Town Council

5. The number of councillors to be elected for the wards of Immingham shall be 15 (fifteen).

Wards of Immingham and numbers of councillors

6.

- (1) The existing wards of Bluestone, Central and Humber, shown marked and edged in red on map 1, shall be abolished.
- (2) The Town Council shall be divided into 2 wards which shall be named North and South (as shown on the attached map 2).
- (3) Each ward shall comprise the area designated on map 2 by reference to the name of the ward and demarcated by red lines.
- (4) The number of councillors to be elected for each ward shall be North (7 town councillors) and South (8 town councillors).

Elections for the parishes of Barnoldby Le Beck and Waltham

7. The elections for all parish councillors for the parishes of Barnoldby Le Beck and Waltham shall be held on the ordinary day of election of councillors in 2027.

Number of parish councillors for the parishes of Barnoldby Le Beck and Waltham

8. The number of councillors to be elected for the parish of Barnoldby Le Beck shall be 6 (six).
The number of councillors to be elected for the parish of Waltham shall be 15 (15).

The boundaries of Barnoldby Le Beck Parish Council and Waltham Parish Council

9. The new boundary between Barnoldby Le Beck Parish and Waltham Parish is shown marked in green on the attached map 3.

The area marked hatched in red on the attached map 3 shall cease to be part of Waltham Parish Council and shall become part of Barnoldby Le Beck Parish Council.

Electoral register

10. The registration officer for the borough shall make such rearrangement of, or adaptation of, the register of local government electors as may be necessary for the purposes of, and in consequence of, this Order.

Order date

11. 1st April 2027 is the order date for the purposes of the Local Government (Parishes and Parish Councils) (England) Regulations 2008.

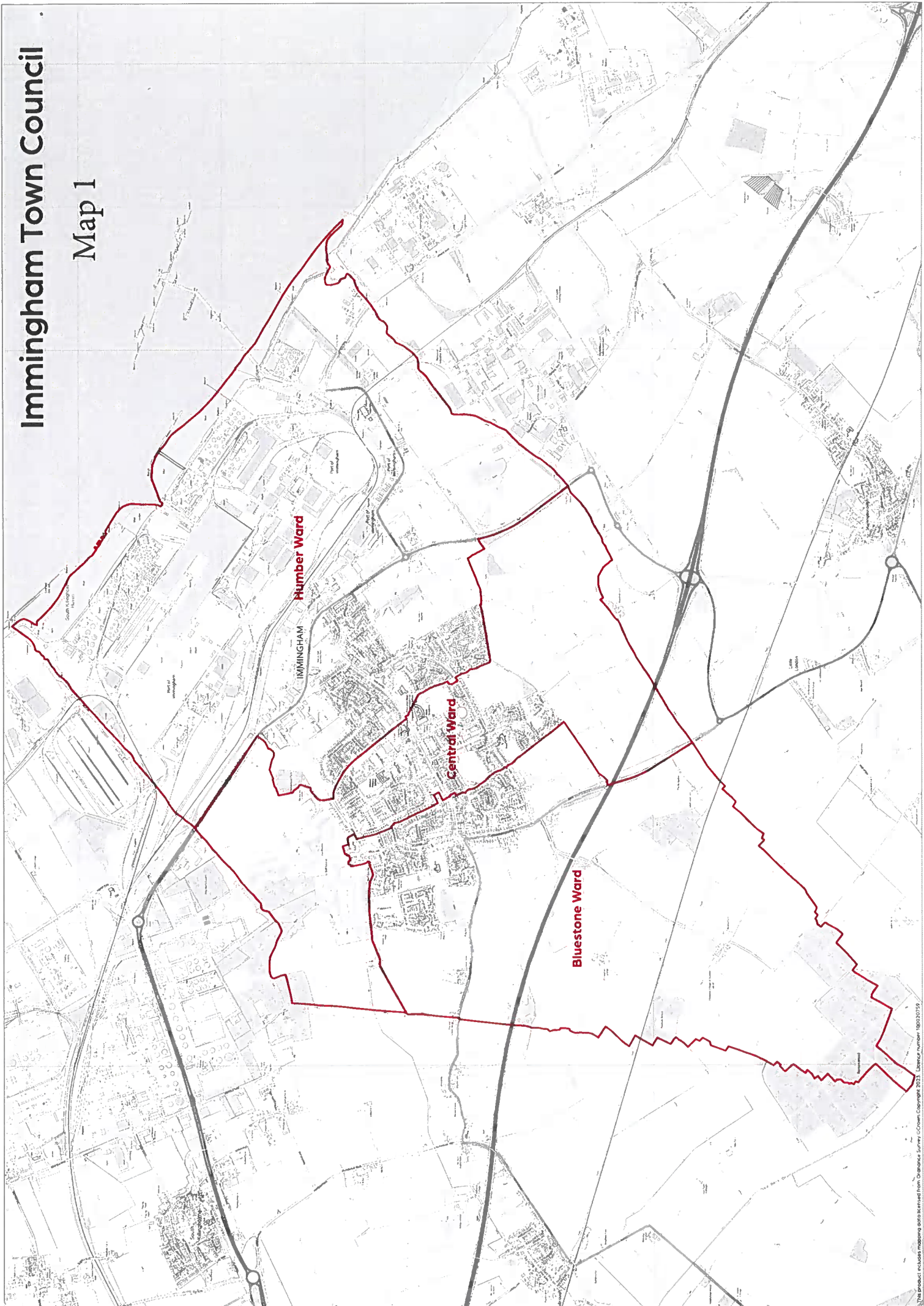

Map 1

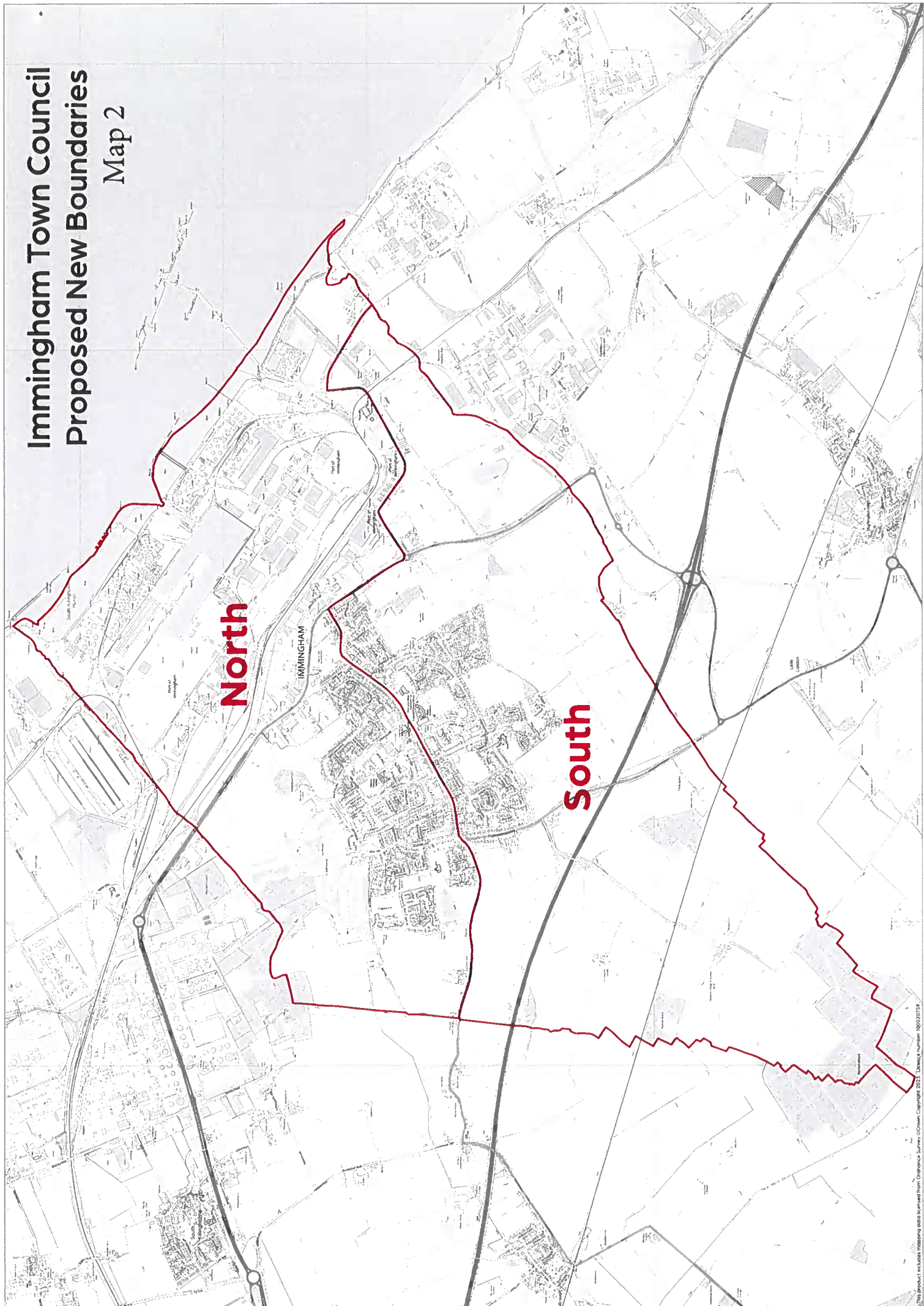


Immingham Town Council Proposed New Boundaries Map 2
