Thurrock Borough Council Boundary Review – The Council’s Submission

Dear Sir,

Please find below the consultation response agreed by Thurrock Council in respect of the ward patterns for the borough.


This response was approved by group leaders by email. This agreed the recommendations of the Council’s working party of councillors supported by officers and taking into account the Commission’s criteria for ward creation of electoral equality, local communities and the promotion of effective and convenient local government. The Council’s submission is as follows:

1. There was an agreement to change the boundary between the proposed wards of Aveley and Purfleet-on-Thames to the A1306, until it crosses the Mar Dyke, and then following the Mar Dyke down to the borough boundary.
2. Corringham and Fobbing – an agreement with the proposal.
3. East Tilbury, Linford, and West Tilbury – an agreement with the proposal.
4. Grays South – an agreement with the proposal, except to change the name to Grays Riverside.
5. An agreement to move 150-156 Long Lane to Little Thurrock Blackshots from Stifford Clays. An agreement for the rest of the proposal for Little Thurrock Blackshots.
6. Ockendon North – an agreement for Mollands Lane and Mollands Court to be in this ward and a name change to Ockendon.
7. An agreement for ‘Ockendon South’ to be renamed Belhus. An agreement for North Stifford not to be in a ward with Belhus.
8. Stanford-le-Hope North. An agreement to change the name of the ward to The Homesteads, Corringham Town, and Stanford East.
9. Stanford-le-Hope South – an agreement with the proposal.
10. Tilbury North – an agreement to change the name to Tilbury St. Chads.
11. Tilbury South – an agreement to change the name to Tilbury Riverside.

12. West Thurrock and South Stifford, Chafford West, and Chafford East – an agreement to change the Devonshire Road boundary.
13. Chafford West – an agreement on the ward name and the change (see point 3.) on Devonshire Road.
14. Orsett, Horndon, and Bulphan – an agreement on the ward name, but not on ward boundaries.
15. Chafford East - an agreement on the ward name, but not on ward boundaries.
16. Little Thurrock Rectory - an agreement on the ward name, but not on ward boundaries.
17. Grays North - an agreement on the ward name to be changed to Grays Town, but not on ward boundaries.

Please can you acknowledge receipt of our submission and please do not hesitate to contact me with any queries. The Council and its councillors look forward to the Boundary Commission's proposals for ward boundaries.

Good afternoon Paul

Whilst working on the draft proposed wards my team have raised some queries on the proposed boundaries. Please could you check the following points?

- 82 to 88A Hogg Lane is not included within the draft ward for Chafford East along with the rest of Hogg Lane. It is currently in the proposed ward for Grays North. We believe this may be an error as it makes more sense geographically to be in the proposed Chafford East ward.
- Turnpike Lane properties - Gunhill Farm, Turnpike House and Turnpike Cottages have West Tilbury addresses and postcodes and have always been included with West Tilbury. We believe, due to proximity and access to West Tilbury, they should be in the proposed East Tilbury, Linford and West Tilbury ward, not Chadwell St Mary ward.

Aveley and Purfleet on Thames - the cut should be along the A1306 London Road/Arterial Road not the A13. 191 to 247 Purfleet Road, Named Properties on London Road and Ship Lane Caravan Park should be included in Aveley not Purfleet-on-Thames.

- Purfleet/ Aveley – all the properties in question are Aveley addresses and would be better placed in Aveley so by moving the boundary to A1306 London Road/Arterial Road makes more sense.
