To Whom it May Concern;

I am writing on behalf of Allesley Parish Council, in particular my constituent [REDACTED], in regard to the new electoral arrangement for Coventry City Council.

Allesley Parish Council raised their concerns about significant changes between the draft recommendations (October 2023) and final recommendations (May 2024) of the electoral arrangements in relation to their parish boundary. From the draft recommendations, Ms Chatterton understood that Allesley Parish Council's boundary would end at the A45, above and excluding the new Eastern Green Sustainable Urban Development (SUE). The Parish Council was satisfied with this proposal. In contrast, the Eastern Green SUE is included within Allesley Parish Council's boundary in the final recommendations; The Eastern Green SUE will be included in the Eastern Green Parish Ward, one of two wards within the larger Allesley Parish Council.

Allesley Parish Council object to the inclusion of the new Eastern Green SUE within their boundary as they feel their rural parish council would struggle to meet the needs of this new urban development. They further believe the decision to include the Eastern Green SUE within their parish boundary demonstrates a lack of understanding from the Local Government Boundary Commission of the locality.

After reviewing the draft recommendations and final recommendations attached, I have not been able to identify the changes mentioned by my constituent. It appears both recommendations include the SUE in the Eastern Green Parish Ward, part of the larger Allesley Parish Council.

In order to best support my constituents, I ask for your assistance in clarifying the following:

- At which point prior to the final recommendations (consultation, submission from interested parties or draft recommendations) was the option considered to exclude the Eastern Green SUE from Allesley Parish Council's boundary?
- For what reasons did the Local Government Boundary Commission then alternatively propose the Eastern Green SUE be included within Allesley Parish Council, as one of two parish wards?
- What consultation did the Local Government Boundary Commission undertake with Allesley Parish Council prior to the final recommendations?

### **Electoral review of Coventry City Council**

Thank you for your letter of 18 August 2024 on behalf of Allesley Parish Council. I'm sorry that the Parish Council has concerns relating to our final recommendations for Coventry City Council, and I will seek to address these in turn.

The Commission's draft recommendations, which were published in October 2023 and are available [here](#), proposed that the Eastern Green SUE be included in the Commission's proposed Woodlands ward, with the remainder of Allesley parish remaining in Bablake ward. Our final recommendations, which were published in May 2024 and are available [here](#), made no change to our draft recommendations for this area.

In your letter, you mention that Allesley Parish Council believed that the draft proposals meant that its parish boundary would end at the A45 road; in fact, it was the proposed district ward that was to end at this boundary. The Commission has no power to amend the external boundaries of parishes, and we sought to explain this in response to the Parish Council's submission in our final recommendations report, at paragraphs 51-57.

The power to amend parish council boundaries is solely the preserve of the local authority by means of a Community Governance Review (CGR). As a result, the Eastern Green SUE will remain part of Allesley Parish Council until such time as Coventry City Council completes a CGR to amend the external boundary and makes an order to enact this change.

If we divide a parish between city wards, as is the case with Allesley parish, we are required to propose parish wards for that parish. We did this for Allesley Parish Council in both our draft and final recommendations and provided the parish with two parish wards, each with a number of parish councillors based on a 5-year forecast of electors. Any parish warding can be superseded by an order made by the City Council following a Community Governance Review. Any such changes would need the consent of the Commission under the legislation.

In respect of our consultation process, Allesley Parish Council, along with other parish councils in the city, were named as key stakeholders in our preliminary discussions with the City Council. The Parish Council would therefore have received a letter at the start of each stage of our review process with details of how to make a submission to the Commission. As we provided parish warding for Allesley Parish Council under our draft and final recommendations, it also received a letter from the Commission individually tailored to the Council, with a map of our proposed parish wards.



I hope that this response answers the queries you have raised in your letter.

In terms of next steps, we plan to lay a draft Order in Parliament to implement our recommendations for Coventry City Council this autumn. We will notify you when this happens.
