Thank you for your request for information, dated 26 June 2024, under the Freedom of Information Act 2000.

Please see below the information you requested, with our response under each question.

1. When are you next going through an audit of the national fraud initiative?  
**Although we are an independent body, we would be covered by the guidance provided for central government departments and would be able to submit the two data sets should we choose to do so. While the NFI is not mandatory, we will consider submitting our payroll and supplier data in the next round of the NFI.**
2. What current procedures do you have in place such as confirmation of payee against fraud?  
**We have in place security call for bank detail amendments. In addition, confirmation of payee checks are being introduced by our bank, which we understand will be in place soon. These check the name of the account holder we intend to pay, against the details held for that account by the payee's bank. This provides greater assurance that payments will be made to the intended recipient and not accidentally or deliberately misdirected.**
3. What is your current confirmation of payee software incumbent product & the renewal date of the contract  
**This is not applicable to us, as we make payments using our online banking system.**
