We generally support Wokingham Borough Council's submission for Earley - but propose some boundary lines that better reflect the interests and concerns of local communities. Lower Earley lies at the southern end of the parish of Earley and is the site of a development that was, by the time it was completed in the mid-1980s, considered to be the largest private housing development in Western Europe. Most of its properties lie in the Hawkedon and Hillside borough wards. Some properties to the north of Rushey Way (Sellafield Way, Markby Way, Toseland Way and roads off) lie in St Nicolas ward and the boundary review provides an opportunity for residents living there to belong to neighbouring communities in Hawkedon and Hillside wards. This is what Wokingham Borough Council proposes but there are community issues around some of their proposed boundary lines. South East Earley/North Earley: The council has drawn a boundary line down the middle of Mill Lane and Wokingham Road that puts residents living on different sides of these two roads in different wards and communities. Proposal 1: A boundary to the east of odd numbered houses on Mill Lane and to the south of even numbered houses on Wokingham Road that puts all residents of these roads in North Earley. West Earley/North Earley: The council has drawn a boundary line down the middle of Gipsy Lane that puts residents living on different sides of the road in different wards and communities. Proposal 2: A boundary continuing along the stream to the south of Gipsy Lane that puts residents in houses 2-23 in North Earley. The council's boundary line puts Rose Cottage on Mill Lane in West Earley. Proposal 3: A boundary that puts Rose Cottage, along with other properties in Mill Lane, in North Earley. Proposal 1: A boundary to the east of odd numbered houses on Mill Lane and to the south of even numbered houses on Wokingham Road that puts all residents of these roads in North Earley.

West Earley/North Earley

The council has drawn a boundary line down the middle of Gipsy Lane that puts residents living on different sides of the road in different wards and communities.

Proposal 2: A boundary continuing along the stream to the south of Gipsy Lane that puts residents in houses 2-23 in North Earley.

The council's boundary line puts Rose Cottage on Mill Lane in West Earley.

Proposal 3: A boundary that puts Rose Cottage, along with other properties in Mill Lane, in North Earley.

In summary, we believe all properties in Gypsy Lane, Mill Lane and Wokingham Road should be in the same North Earley ward.
