1. Introduction and Background:

1.1 This submission sets out Tonbridge & Malling Borough Council's response to the invitation from the LGBCE to put forward revised warding arrangements based on the draft recommendation of 43 councillors following the first consultation phase, which considered Council Size.

1.2 It seeks:

- to achieve the identified optimum figure for electoral equality wherever possible,
- to reflect the identities of local communities and
- to promote effective and convenient local government.

1.3 In Tonbridge and Malling, the projected electorate for 2027 is 106,828, this means that with a recommended 43 councillors, each councillor should represent approximately 2,484 electors.

2. Setting out Key Local Criteria

2.1 In addition to the 3 key criteria as set out by the LGBCE, the Council has also applied a number of more detailed 'core local criteria' in order to reach a warding pattern that meets local views on community identity. These are:

1. Parish boundaries should be respected where at all possible
2. The area of Tonbridge & Hildenborough along with Snodland, Larkfield & East Malling and Kings Hill should all be self-contained as they each represent coherent community identities.
3. A number of parished areas have a close relationship with each other and, where at all possible, should be kept together in any future warding arrangements – these are:
 - Borough Green and Platt
 - Birling and Ryarsh
 - Addington and Trottiscliffe
 - Burham and Wouldham
 - Mereworth and Wateringbury

2.2 A number of other key local considerations were also agreed which have influenced the proposals. These include:

- That 'Ightham, Wrotham and Stansted' has a coherent identity that looks more towards Addington and Trottiscliffe than it does towards Borough Green, Platt or Plaxtol.
- That East Malling being paired up with either Kings Hill or Ditton does not form a coherent identity.
- Wateringbury being linked to Kings Hill does not make sense from a community identity perspective.
- That the area along the border between Ditton and South Aylesford forms less of a community divide and could therefore be flexed to accommodate a future warding pattern.
- That Ryarsh and Birling have stronger links to Leybourne than they do with Snodland.

3. Building Blocks of the Proposal:

3.1 In considering warding patterns, the Borough Council then used the 3 LGBCE criteria, and the key local criteria to start pulling together building blocks of potential future wards. In doing so, a clear pattern started to emerge:

- Tonbridge and Hildenborough – **13** Councillors
- Snodland – **4** Councillors
- Kings Hill – **3** Councillors
- Larkfield and East Malling – **5** Councillors
- Borough Green & Platt – **2** Councillors (could be expanded to make 3 Councillors)
- Leybourne, Ryarsh and Birling – **2** Councillors (could be expanded to make 3 Councillors)
- Ightham, Wrotham, Stansted, Addington and Trottiscliffe – **2** Councillors (could be expanded to make 3 Councillors)
- Burham and Wouldham – would need to be joined with another area to meet electoral equality thresholds for **2** Councillor - the viable options would be joining with Eccles (2 Councillor ward) or joining with Blue Bell Hill and Walderslade (which would create a 3 Councillor ward)
- Mereworth and Watlingbury – **1** Councillor (could be expanded to make a 2 or 3 councillor ward)

3.2 In total, these building blocks account for areas of the borough that could ultimately make up wards for approximately 33-34 Councillors.

4. Proposed Warding Pattern:

4.1 The proposed warding pattern put forward by Tonbridge & Malling Borough Council provides a mixed warding pattern of single member wards, two member wards and three member wards based on the statutory criteria.

4.2 Appendix 1 provides an overview of the proposed wards, setting out information on electoral equality and community identity. In addition, the following table also illustrates how the electoral equality will balance out for each of these proposed wards by 2027:

4.3 For the purposes of clarity, this submission provides a breakdown, ward by ward to help explain the geography proposed:

4.3.1 **Aylesford:** This ward comprises 4 existing polling district areas that all lie within Aylesford Parish – 3 complete polling district areas (CAA, CAB and CAD) and the majority of CBA. A small portion of CBA is moved over to Ditton and Holtwood (see 4.3.3). This ward has strong road connections running north to south via the A229 and Rochester Road, linking Walderslade to Aylesford. Aylesford has a number of facilities that serve the ward, with Aylesford School catchment area extending into Walderslade and the regular Aylesford Farmers Market acting as a draw from a wide area. Whilst the M20 runs across the ward east to west, this is not a barrier that defines community identity as there is unconstrained access along both Hall Road and Station Road:

4.3.2 **Burham, Eccles and Wouldham:** One of the reasons for this current review is because the existing ward of Burham and Wouldham is a significant distance from an acceptable variance. Therefore, in

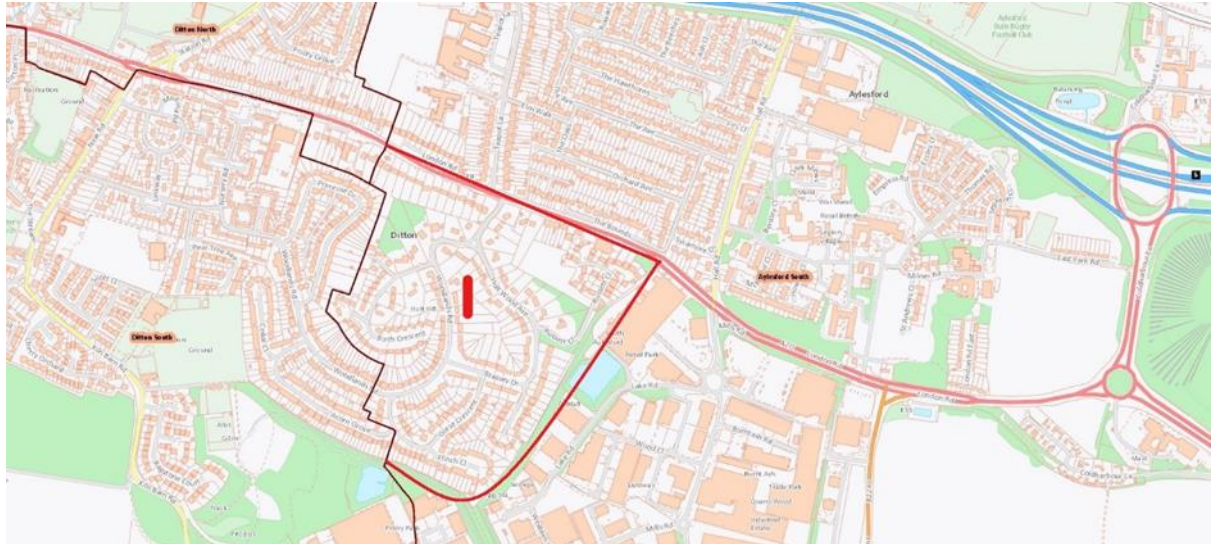
order to retain its two members, it is proposed to include Eccles within this ward. As such, this ward comprises three polling district areas (CAC, CCA and CCB) and reverts back to a warding pattern that was in place prior to 2015 and ensures all of the east bank villages are represented in the same ward:

The 900-home development at Bushey Wood (outskirts of Eccles) is an 'area of opportunity' in the existing Tonbridge & Malling Local Plan, and was also included as an allocation in the new Local Plan, which was rejected by the Planning Inspectorate. Despite this, a planning application is scheduled to be submitted to the Planning Department in October 2021, and so with two major developments taking place in this ward (Bushey Wood and Peters Village), and the additional burdens on Members in supporting these new communities as they grow, it is suggested that ideally this ward would be better represented by 3 councillors rather than 2 if the circumstances allowed (making 44 councillors in total).

- 4.3.3 **Ditton and Holtwood:** comprises 3 polling district areas – CDA and CDB in Ditton, plus part of CBA, which has been marked as '1' in the map below. As per the key local considerations, it was felt by Members that the existing boundary around the Woodlands Road area is far from clear, and it is in the best interests of all residents that the whole of Woodlands Road is included within the same ward. As such the boundary has been moved to the A20 as a more recognisable barrier. Woodlands shopping parade and nearby sports and community facilities (K Sports Cobdown and Ditton Community Centre) all act as strong community hubs for the entire ward.

4.3.4 **Snodland:** As set out in Section 2, the proposal aims to keep Snodland self-contained (an area represented by 4 councillors) in order to best represent an area with a coherent identity. The best way of achieving this in a balanced way is to create 2 2-member wards which adhere closely to the existing polling district boundaries, but with amendments for the purposes of electoral equality:

- a) **Snodland East and Ham Hill:** comprises the existing Snodland East and Ham Hill ward, but with an adjustment to polling district CHA to include Malling Road, Bramley Road, Chapel Road, Bullfields, Recreation Avenue, St Katherine's Lane, Wyvern Close, Orchard Way, Meadow Walk, Portland Place and High Street within the proposed new ward:

- b) **Snodland West and Holborough Lakes:** is essentially the whole of the existing Polling District CHA apart from those roads moved into Snodland East and Ham Hill for reasons of electoral equality:

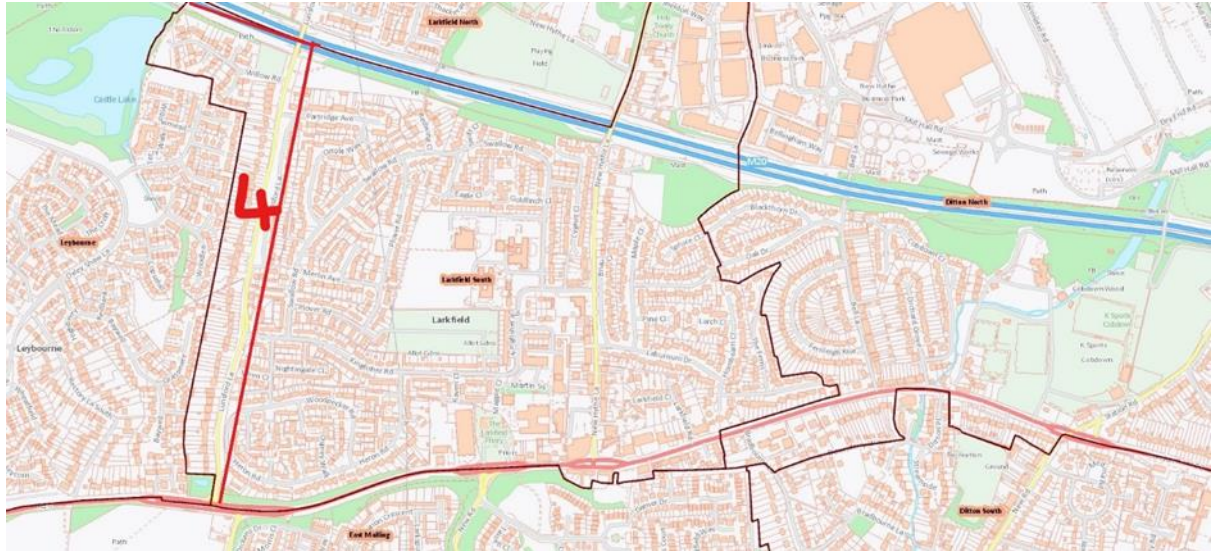

- 4.3.5 **Larkfield:** comprises the existing Larkfield North and Larkfield South wards, except for a small area of Larkfield South which is allocated into the proposed East Malling and Lunsford ward for the purposes of electoral equality. Ideally, Members would prefer a 3-member ward covering the existing area of Larkfield (North and South) and a 2-member ward covering East Malling, however, this is not possible under the forecast figures for 2027. As such, in order to create electoral equality an area around Lunsford Lane has been removed from this ward and placed in East Malling and Lunsford (see 4.3.6)

- 4.3.6 **East Malling and Lunsford:** As referenced in 4.3.5, this proposed ward comprises the existing East Malling ward plus part of Larkfield South ward around Lunsford Lane and Willow Road as demonstrated on the map below (area marked '4'):

The proposed East Malling and Lunsford ward is forecast to be at approximately 10% variance. However, in recent months there has been considerable progress at a couple of development sites within East Malling – Parkside (110 houses) and Forty Acres (250 houses) – that could either bring this proposed ward to a lower variance, or potentially enable the retention of the existing boundary between East Malling and Larkfield.

- 4.3.7 **West Malling:** The links between West Malling and Leybourne, which form an existing ward, are very strong and it is proposed to keep this arrangement. However, it is proposed that Birling, Ryarsh and Offham are included within this ward.

West Malling is an historic town that has acted as a focal point for the surrounding area for centuries. However, following the development of Kings Hill and the development of the Ashton Way bypass an obvious boundary has been created between East and West Malling. As such, this ward reflects the stronger links that West Malling now has with Leybourne and the surrounding rural areas to the north and west.

Offham has strong links to West Malling and Leybourne through the number 70 bus link, and looks to West Malling for all its services. Birling and Ryarsh are very closely linked with Ryarsh Primary School serving Birling, and strong road links between the two settlements. Both these villages look towards West Malling and Leybourne for their nearest GP practice.

The proposed name of West Malling reflects the fact that West Malling is the main town within the ward and acts as the main service centre for the rest of the ward:

- 4.3.8 **Kings Hill:** comprises polling districts TKA and TKB covering Kings Hill parish. This ward accords with the wish of Members to see Kings Hill (not including the Airfield Estate) self-contained, recognising its strong sense of community identity. With only two access roads in and out of the settlement, it does not fit easily with any of its neighbours. Fortunately, it can retain its current 3-members based on future growth projections.

- 4.3.9 **Mereworth and Watlingbury:** comprises Mereworth and Watlingbury parishes (polling districts TKC, TDC and TPA) and adheres to the core local criteria of making sure Watlingbury and Mereworth are placed in the same ward. For Watlingbury, the closest connection it has to any another area in the borough is with Mereworth (via the A26), which are joined by the number 7 bus. Indeed, the road network to other parts of the borough either involves going into Maidstone borough (to reach East Peckham) or to navigate smaller roads (to East Malling). As such, a one-member ward is proposed.

The creation of this ward also allows for the Airfield Estate to move back to a ward with the rest of Mereworth Parish.

- 4.3.10 **Borough Green and Platt:** comprises the parishes of Borough Green and Platt, adhering to the core local criteria. This proposed ward reflects the closeness of the two communities, and like Aylesford and Ditton, development goes right up to the border between the two parishes (along the A25).

Whilst still clearly villages, this area is more densely populated than the surrounding parishes, with a focus on Borough Green High Street as the local centre and a number of other shared facilities such as King George's Field which is situated near to the boundary. The issue of air quality (arising from the A25) is also a common issue faced by both parishes.

- 4.3.11 **Pilgrims:** comprises the rural parishes of Addington, Trottiscliffe, Ightham, Stansted and Wrotham, and fits with the key local consideration that the existing 'Wrotham, Ightham and Stansted' ward looks more towards Addington and Trottiscliffe than it does towards Borough Green, Platt or Plaxtol. Many of the challenges facing these villages are shared – such as protection of the Kent Downs AONB, the impact of the M20 and M26, and supporting the rural economy - and it is proposed calling this ward 'Pilgrims' because the Pilgrims Way runs through it from east to west.

- 4.3.12 **Bourne:** covers the rural parishes of Plaxtol, Shipbourne, Hadlow and West Peckham that lie to the north and east of Tonbridge. Hadlow retains many services in its own right, many more than some of its smaller neighbours. As a result, the ward proposed has Hadlow at its heart, serving the surrounding rural villages and hamlets. This ward has the River Bourne running through its heart from the far north in Plaxtol to Golden Green in the south, as such it is recommended that this ward be referred to as 'Bourne' considering the shared identity.

The use of 'Bourne' also accords with The Bourne Partnership, which is a partnership between Hadlow Primary School and Shipbourne Primary School, which share an Executive Headteacher. In addition, Plaxtol Primary School has a catchment area that Hadlow and West Peckham.

- 4.3.13 **East Peckham:** a proposed one-member ward comprising the parish of East Peckham. Given its size and location on the eastern boundary of the borough, a one-member ward that is co-terminous with the parish boundary is considered appropriate. Indeed, the main road that serves East Peckham (the A228) ensures that, in many ways, most of the residents in this area look more closely to Paddock Wood, Tunbridge Wells and Maidstone than other parts of Tonbridge and Malling borough. This is illustrated by the way in which the local community access education and health facilities.

- 4.3.14 **Tonbridge and Hildenborough:** the area of Tonbridge and Hildenborough covers a cluster that amount to 13 councillors. The Council feels that the existing boundaries do still substantially reflect the communities within this area and as such, in order to achieve electoral equality, the proposals look to alter boundaries in parts of the town that are most arbitrary:

- a) **Tonbridge North East:** comprises the whole of the existing Higham ward along with adjoining areas of Cage Green. The proposal for this ward has Martin Hardie Way at the heart, rather than on the edge as it currently now is, and includes those residential areas that look towards it as their local centre. Martin Hardie Way includes a range of local facilities and shops, along with a Methodist Church which is located nearby.

The area of TBA proposed to be included in this ward covers Whistler Road (1-29 odd, 2-8 even), Knight Road, Landseer Close, Reynolds Close, Raeburn Close and Rembrandt Close. This area is marked '2' on the map below.



The area of TBB falling within this ward includes Royal West Kent Avenue, Norwich Avenue and all roads off Salisbury Road. These are the roads within the Polling District which are not included within Tonbridge East (see section on Tonbridge East)

- b) **Tonbridge North West:** comprises the remainder of TBA (i.e., the part of the polling district not within Tonbridge North East as referenced above) and the existing Trench ward.

York Parade acts as the central focus for this ward, and this proposal would ensure that York Parade and the Sainsbury's over the road (which is now well connected following the recent installation of a pedestrian crossing) are no longer separated by an arbitrary ward boundary.

- c) **Tonbridge East:** comprises the existing Medway ward at its core, along with parts of the existing Castle and Cage Green wards, along with a small area of the existing Vauxhall ward. It is proposed to call this area 'Tonbridge East' to avoid confusion with the unitary authority in Kent, which is called 'Medway'.

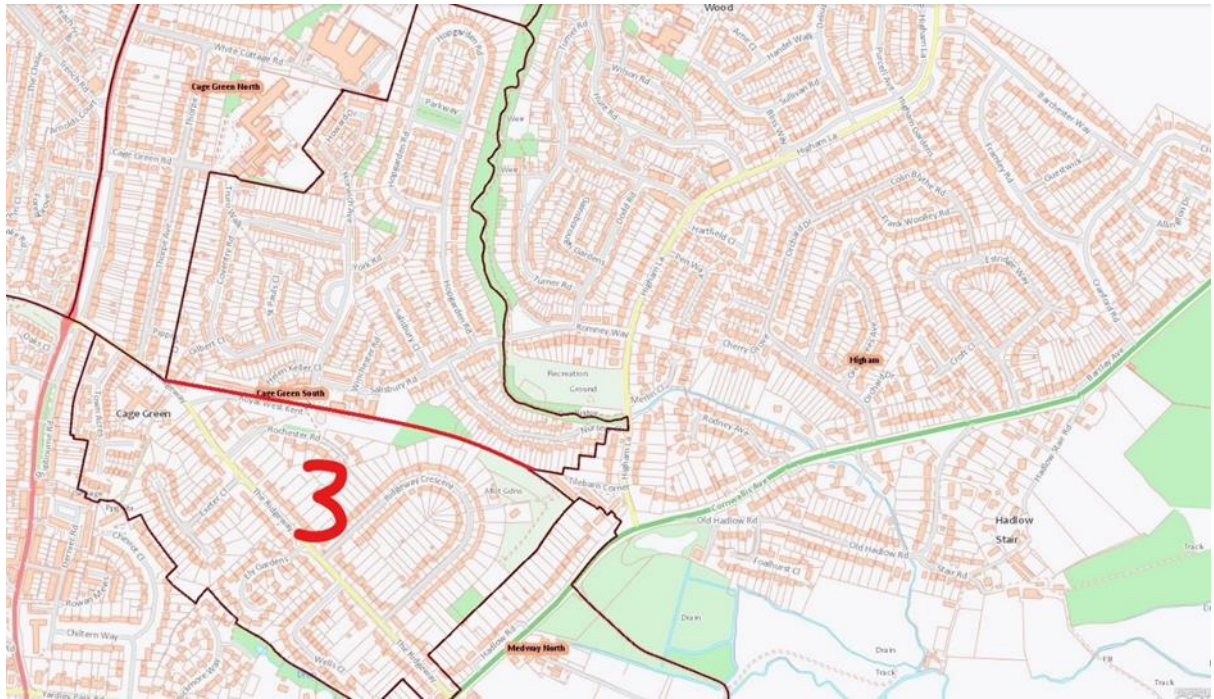
The creation of Tonbridge Retail Park in the last 5 years has created a new shopping area focus for residents in the east of the town, and as such residents in polling district TLB do look much more towards this area than Quarry Hill Parade, as such it is felt that it is appropriate that this Tonbridge East ward crosses both the River Medway and the railway line as it does so at the moment. In addition, there are strong footpath links between this area and the areas to the north of the river.

The inclusion of The Ridgeway and Yardley Park Road within this ward is related to the strong concerns that exist around traffic safety along the A26 at these junctions. For reasons of effective local government, it makes sense that these areas form part of one ward rather than be on the border of multiple wards.

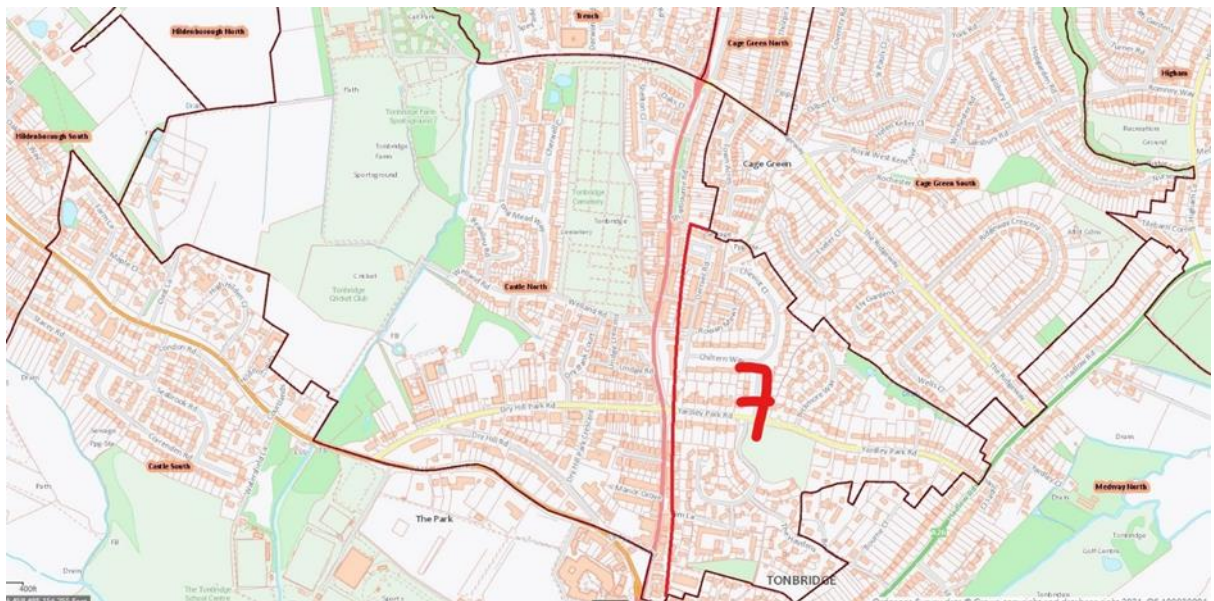
The number 208 bus service also provides a strong link between The Ridgeway and the far south of this proposed ward.

It is proposed that The Ridgeway and all roads off it (excluding Royal West Kent Avenue and Thorpe Avenue), which are located within Polling District TBB are included within Tonbridge East (as marked '3' on the map below).



In addition, it is proposed that the area adjoining the Ridgeway, which is located within Polling District TCA, and comprises Yardley Park Road and all roads off it, including Haydens Mews, Cheviot Close, Dernier Road and Rowan Mews, is also included within Tonbridge East ward (as marked '7' on the map below).



Finally, it is proposed that an area of Pembury Road is also included within Tonbridge East – this covers 93-157 Pembury Road (TNA Polling District) – marked '5' on the map below - and 54-124 Pembury Road and Magnolia Close – marked '6' on the map below (TNB Polling District).



- d) **Tonbridge South:** comprises the existing Judd ward and the majority of Vauxhall ward (bar the areas marked '5' and '6' in the maps above, which are proposed to join Tonbridge East for reasons of electoral equality). It is proposed to keep the existing boundary between the current Castle and Judd wards as this is essentially defined by the natural barrier of the River Medway.

This area has a very similar housing stock, built up around the time of the arrival of the railway in the 1840s. Quarry Hill Parade represents a focal point for facilities that serve the surrounding area, supported by the station itself at the northern end of the parade and St Stephens Church to the south. Haysden Country Park also provides the nearest high quality open space for residents within this ward.

In terms of transport connections, the 211 bus serves this ward, with Public Rights of Way also providing quick links to and from the nearest primary school and Sussex Road.

- e) **Hildenborough and Tonbridge West:** when assessing the LGBCE criteria it was concluded that Hildenborough had much more in common with Tonbridge than its other neighbour, Shipbourne, where the only connection between them is one rural lane (Riding Lane). In addition, the vast majority of residents in Hildenborough live much closer to Tonbridge than Shipbourne. Indeed, the connections between Hildenborough and Tonbridge are strong and well-established:

- the railway station at Hildenborough lies on the line between Tonbridge and Sevenoaks, and the local rail user group (Tonbridge Line Commuters) covers issues at both Tonbridge and Hildenborough stations.

- The 402 bus provides a direct link along the B245 into Tonbridge, as does the 202 which heads to the Brookmead Estate.

There are also very strong ties when it comes to education establishments and health facilities. The ‘Tonbridge North and Hildenborough’ planning group at Kent County Council focuses on 6 primary schools across this area, and the local GP surgery is part of the Hildenborough and Tonbridge Medical Group.

Finally, the area of Hildenborough and Tonbridge West is united in the common issue of helping to mitigate flooding of the River Medway. The Leigh Expansion and Hildenborough Embankment Scheme is currently in development and is of huge interest to residents across the area, therefore this area would be best represented by the same ward in order to achieve effective local government.

Therefore, as Hildenborough is unable to retain its existing two members due to its size, the best solution is to join with some of Tonbridge in the existing Castle ward. As such, this ward comprises the parished area of Hildenborough, and the area of the existing Castle ward that lies west of the Shipbourne Road (i.e., not including the area around Yardley Park Road which will move in to Tonbridge East).

5. Concluding Comments:

- 5.1 These proposals were agreed by Full Council on 13th July 2021 as the Council’s submission to the Commission in respect of warding arrangements in Tonbridge and Malling borough. The council considers that the submission meets the three key criteria – electoral equality, strong ward boundaries that reflect communities and will deliver effective and convenient local government in the Borough.
