I believe that this would be better for Derby as it would give me a greater say in who represents me on Derby City Council.

I support these proposals as it would reflect my community better by uniting areas that are currently split, and allowing neighbourhoods to get their own voice.

I urge the Boundary Commission to take on board Labour's suggestions for two Councillor wards, so that more areas of our great city can have their seat on the City Council.
