Epsom & Ewell Labour Party boundary review proposal

1. Introduction

Over the past five to twenty years there has been substantial development on the old Epsom hospital sites. The Epsom cluster as the hospitals were known cared for patients with mental health conditions and learning difficulties. The hospital cluster has played a significant part in shaping present day Epsom, its economy and its current population and culture, bringing diversity as well as employment and opportunities to the town.

The new housing/residential estates have, caused imbalances in existing wards, primarily Stamford and Court wards and to a lesser extent, Ruxley ward.

Additionally, Town ward is the most densely populated ward in the borough with the highest population of residents. It also suffers from having the main Waterloo rail line running through it which creates physical barriers to establishing coherent resident communities in the ward.

These are the main issues in the borough and this boundary review provides the opportunity to correct the imbalances in Stamford and Court ward and address the density issues with Town ward while also correcting a number of historical anomalies.

2. Creation of new ward

There is merit to creating a new ward called "Horton Park" based on the new estates which lay alongside Horton Lane. Namely:

Clarendon Park (currently in Ruxley) Livingstone Park (currently in Court) Manor Park (currently in Stamford) Noble Park (currently in Stamford)

These developments were intended to provide a more "rural" rather than an urban feel for residents as they are largely separated by green belt land. Their identities are based on their proximity to Horton Lane, Horton Country Park and parade of shops which includes Tesco minimart. The residents of these communities' are likely to use Horton Country Park for leisure and the parade of shops built within the development for their local retail needs.

Parkviews is separated from the Horton Park developments by Hook Road the main arterial B road (A286) which creates a physical boundary, it differs from them in that it does not share the characteristics of the other developments and does not border Horton Lane and therefore should remain in Court ward.


3.1. Changes to Court ward

Since the previous boundary review the "Gibraltar estate" has been in West Ewell. The Gibraltar estate and the new development built on the Surrey CC Highways House site is separated from West Ewell by the main B road, Chessington Road which creates a physical barrier to developing an affinity with the rest of West Ewell ward. There is greater logic to include the new development and correct the historical anomaly and return the Gibraltar estate to Court ward.

Town ward is the most densely populated ward in the borough with the highest population of residents. It also suffers from having the main Waterloo rail line running through it which creates physical barriers to establishing resident communities on either side of the rail line.

Hook Road and Miles Road in Town ward have similar types of housing in Upper and Lower Court Road. Prior to the last boundary review these properties were in Court ward and it is logical to return these properties as there is greater affinity to houses already in Court ward.

Map 2 New boundaries of Horton Park Ward


