

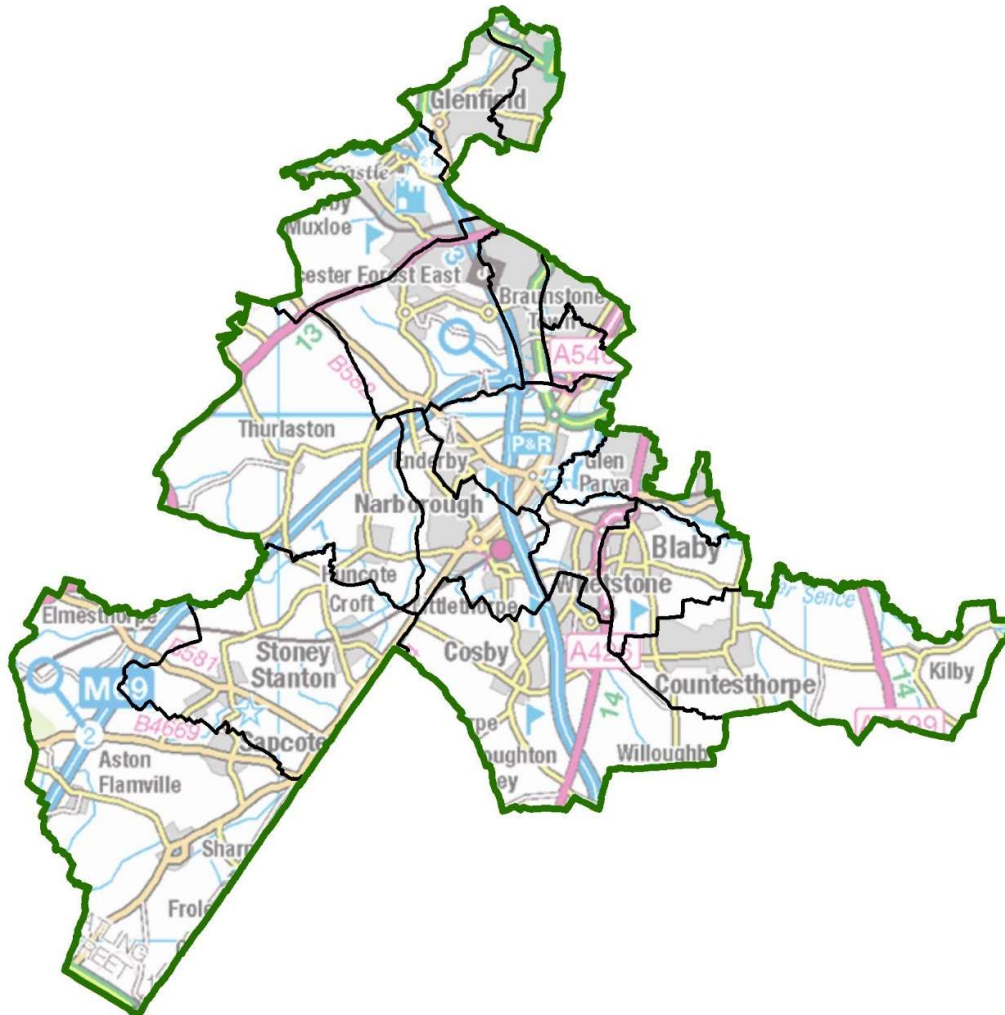
News Release from the Local Government Boundary Commission for England

Have your say on a new political map for Blaby District Council

New boundaries are being proposed for council wards in Blaby District Council.

The Local Government Boundary Commission wants to hear what residents and local organisations think about the proposals. A 10-week consultation on the proposals will run until 11 April 2022.

The Commission is the independent body that draws these boundaries. It is reviewing Blaby to make sure councillors will represent about the same number of electors, and that ward arrangements will help the council work effectively.

The Commission has published proposals for changes to Blaby. It is proposing that there should be 17 wards, one fewer than there are now. The boundaries of 15 wards should change, while three will stay the same. There will be 3 three-councillor wards, 13 two-councillor wards and 1 single-councillor ward across the district.

Proposed changes include:

- Two-councillor Enderby and Glen Parva wards and a three-councillor Narborough & Littlethorpe ward as these are based on whole parishes and secure good electoral equality while using strong boundaries.
- The creation of a three-councillor Leicester Forest & Lubbethorpe ward. It has been necessary to create a three-member ward to absorb the large amount of development forecast for Lubbethorpe parish which would otherwise result in a ward with very poor electoral equality.

Launching the consultation Professor Colin Mellors, Chair of the Commission, said:

“We want people in Blaby to help us.

“We have drawn up proposals for new wards in Blaby. We want to make sure these new electoral arrangements reflect communities. We also want them to be easy to understand and convenient for local people.

“Residents and local organisations can help us do that. We would like them to let us know whether they agree with our proposals before we take final decisions.

“It’s easy to get involved. Go to our website. Or you can e-mail or write to us.

“Just tell us what you think and give us some details why you think that. It’s really simple, so do get involved”
