### Waverley Borough Council Warding Pattern Submission

The following submission, based on a council size of 50, was prepared initially by a cross party Member Working Group and agreed by Council on 6<sup>th</sup> July 2021 with the following resolution:

RESOLVED that a submission on future warding patterns be made to the Local Government Boundary Commission for England comprising Option 2 on Annexe 1 and illustrated in Annexe 2; plus the qualitative comments on warding issues as set out in Annexe 3 of the report.

The attached map (referred to in the resolution as Annexe 2) graphically represents the warding pattern and the table below sets out the elector numbers. The qualitative comments on warding issues by councillors (referred to as Annexe 3 in the resolution) are set out below.

The Council's submission deliberately does not attempt to re-align the ward boundaries for Farnham, Godalming and Haslemere Town Councils and Cranleigh Parish Council areas as the time and resources needed to do this task effectively were not available. Given the foreshortened timescale due to Covid-19 and the period of elections during this consultation period it has not been possible to deliver the level of detail in our response that we would have preferred. We intend to give a more detailed response at the next stage of the consultation.

The Council feels strongly that single member wards do not meet the Commission's criteria of 'promoting effective and convenient local government' as there is a lack of resilience in terms of constituency support for residents should a councillor fall ill or die in office. The submission is based on a premise of creating three councillor wards wherever possible. The rural villages of the borough have been brought together into coherent groupings that make geographic sense whilst maintaining the correct councillor/elector ratio.

Waverley is fully parished and has eight parishes with parish wards. These are: Cranleigh, Farnham, Godalming, Haslemere, Frensham, Ewhust and Ellens Green, Wonersh and Witley. Currently there are parishes which are divided between different Borough wards. The Working Group used parishes and parishes wards as their building blocks for the proposed warding pattern.

The following table sets out the Council's preferred warding pattern (referred to as Option 2 in the Council resolution.)

### Cranleigh, Ewhurst and Ellens Green

Currently Cranleigh Parish is split between 4 Waverley wards. We feel it would be better to have 6 councillors representing the whole of the Cranleigh Parish area together with the whole of Ewhurst and Ellens Green Parish which lies to the east of Cranleigh and has close links in terms of facilities and shopping.

#### Alfold, Dunsfold and Chiddingfold

We recommend one ward with  $\overline{3}$  councillors to cover these villages. Alfold and Dunsfold are closely aligned and were a ward before the 1998 changes.

#### **Eastern Villages**

Currently the existing wards of Blackheath & Wonersh, Shamley Green and Cranleigh North and Witley and Hambledon have large negative forecast variances. Bramley, Busbridge and Hascombe which is in the centre of these wards has a +2% forecast. Combining these villages makes sense geographically and having three councillors will greatly improve resilience over one member wards which would need to exist otherwise.

The name 'Eastern Villages' is the same as the County Council electoral ward and would need to be changed should this be accepted.

#### Western Villages

The current wards in this proposed grouping are the parishes of Thursley, Elstead, Frensham, Dockenfield, Tilford and Churt. The communication links make sense and although they are discrete rural villages there is a coherency about this grouping. The name 'Western Villages' is the same as the County Council electoral ward and would need to be changed should this be accepted.

#### **Milford and Witley**

This proposed ward with three councillors would make a much more coherent community grouping than the current wards which split the parish of Witley into three borough wards.

#### Haslemere, Farnham and Godalming

Using the target councillor/elector ratio of 2,106, an indication has been given as to the recommended number of councillors for each town and an upper limit for wards.

All wards are within the +/-10% tolerance.

As part of its consideration, the Working Group invited all councillors to comment on any significant issues or anomalies with their current ward that they would wish to have addressed through the current exercise. A number of comments have been received which add valuable local intelligence from ward councillors, and these are set out below.

# Comments from ward councillors to be passed to the Boundary Commission

# 1. Cllr Maxine Gale, Ward Member for Witley & Hambledon

Witley Parish is currently split across three wards (Witley & Hambledon, Milford, and Elstead & Thursley) which means that it is represented on Waverly Borough Councillors by six borough ward councillors. The proposed warding pattern of a new three-Member ward for the Witley Parish area would address this inefficiency in local government representation.

# 2. Cllr Joan Heagin, Ward Member for Godalming Holloway

The majority of Holloway ward lies within the ecclesiastical parish of Busbridge, and most residents of Holloway ward would describe themselves as living in Busbridge. Busbridge church, Busbridge village hall, Busbridge infant and Busbridge junior schools are all within Holloway ward. It does cause confusion, including Holloway ward residents contacting Bramley, Busbridge and Hascombe (BBH) ward councillors. The ecclesiastical parish map shows that it is really only parts of Bargate Wood that are in Holloway, but not also in the Busbridge ecclesiastical parish

Some review of Godalming wards is clearly going to be needed, and as part of that maybe some consideration could be given to a new Busbridge & Holloway ward. There are also some properties within Holloway ward currently that would more logically fit within Ockford & Central. These are:

- bottom of Holloway Hill; Rock Place, Firgrove cottages, Troy House and Holt House
- Harvest Hill
- Hazelwood Cottages
- Bonnybrae and Merryhills in Croft Rd
- random properties at the bottom of Brighton Road; everything north of Latimer Road should be Ockford & Central
- top 3 houses in Grove Road
- Busbridge Sidings (which is up a track off Portsmouth Rd)


### 3. Cllr Carole Cockburn, Ward Member for Farnham Bourne

Farnham was divided up artificially last time, leading to nine wards that bore little relation to the natural pattern of community.

Part of the Bourne parish was transferred to Firgrove, a concocted ward with no rationale other than size of population. Moor Park was created and had streets north of the bypass added to make up the numbers.

As Farnham is fully parished with strong communities, it makes more sense to start with parishes and look for natural divisions and then to sort out the required number of councillors per ward (possibly 3-councillor wards again in places).

This really came to the fore in the production of local planning documents: nobody spoke up for parts of Farnham, as they didn't realise they lived there!!
